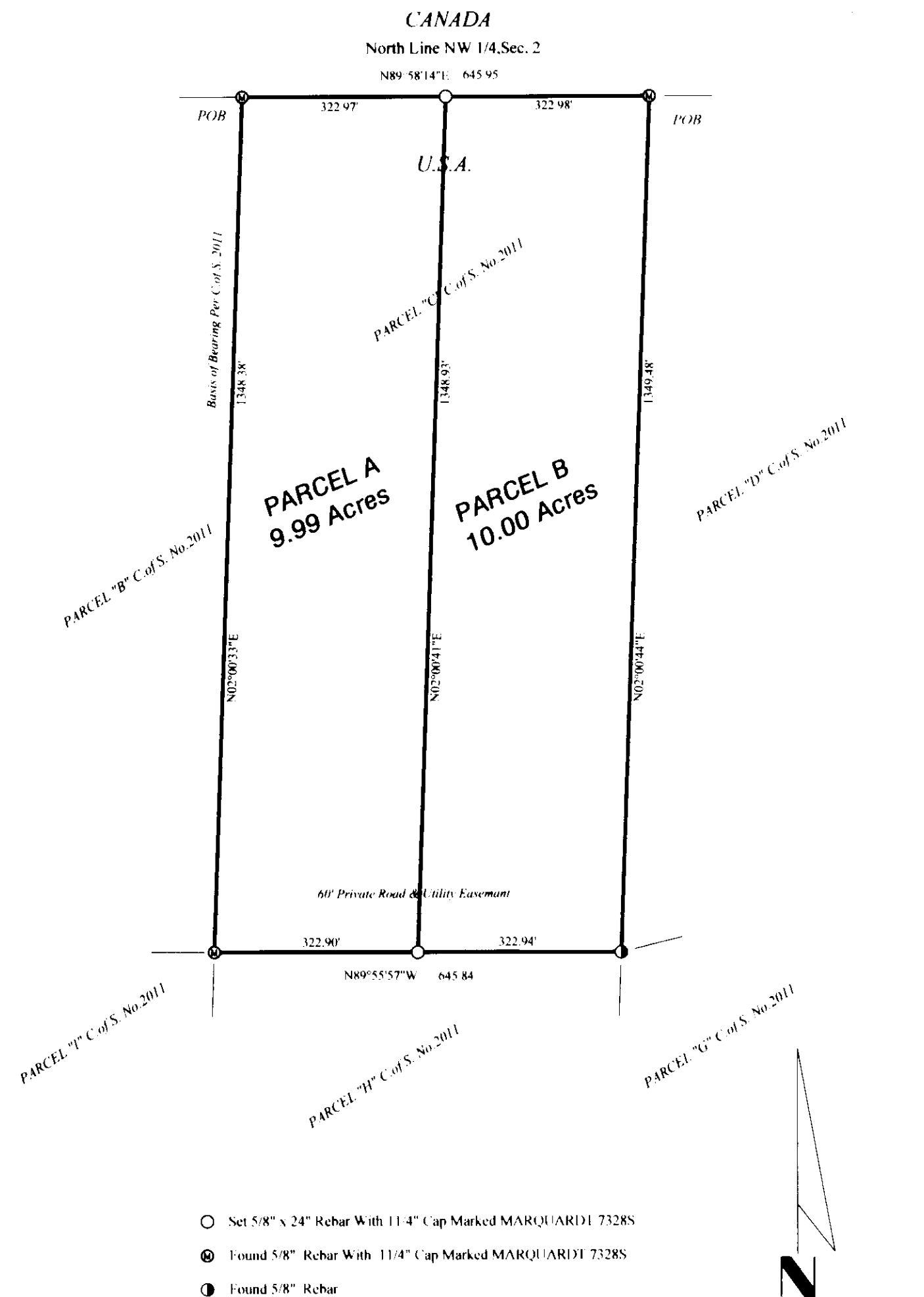
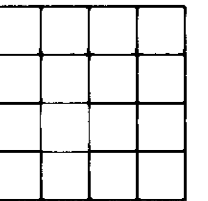

Beginning at the Northwest corner of Parcel C as shown on Certificate of Survey No. 2011, which point is on the North line of the Northwest 1/4, Section 2, said line being the boundary between U.S.A. & Canada;  
Thence along said line North 89°58'14" East 322.97 feet;  
Thence South 02°00'41" West 1348.93 feet;  
Thence North 89°55'27" West 322.90 feet;  
Thence North 02°00'33" East 1348.38 feet to the Point of Beginning containing 9.99 acres of land all as shown hereon.

Thence North 89°55'57" West 322.94 feet;  
Thence North 02°00'41" East 1348.93 feet to the North line of the Northwest 1/4, Section 2, also being the line between U.S.A. & Canada;  
Thence along said line North 89°58'14" East 322.98 feet to the Point of Beginning containing 10.00 acres of land all as shown hereon.

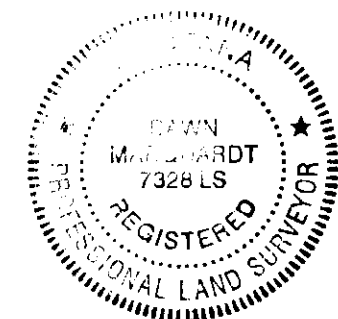
