

DESCRIPTION OF S.T.A. MT-247

A tract of land located near Troy in Lincoln County Montana, lying in the NE 1/4 SE 1/4 of Section 4 Twp. 28N., R.33W., P.M.M. containing .42 acres (18,478 sqft.) more or less and more particularly described as follows:

Beginning at a 3 1/4 inch dia. alum. U.S.D.A. monument stamped K.E.D. 4975-S; which marks the SE 1/16 corner of Section 4 Twp. 28N., R. 33W., P.M.M.; thence, N89°47'08"E 84.59 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N07°13'41"E 164.24 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; N13°35'49"W 58.31 feet to a 5/8 inch dia, rebar capped K.E.D. located on the approximate right of way of Highway No. 56; thence along said approximate right of way along a chord bearing of S58°46'58"W and a distance of 106.50 feet to a P.K. nail set in a concrete pad; thence, leaving said right of way S00°09'53"W 164.73 feet to the point of beginning.
