Thence along the North line of the Northwest 1/4 of the Southeast 1/4 South 89°38'29° East 571.66 feet; Thence South 1322.75 feet to the South line of the Northwest 1/4 of the Southeast 1/4;

Thence along the South and West lines of the Northwest 1/4 of the Southeast 1/4 North 89"51'36" West 578.03 feet and North 00°16'33" East 1324.93 feet to the Point of Beginning containing 17.47 acres of land all as shown hereon
