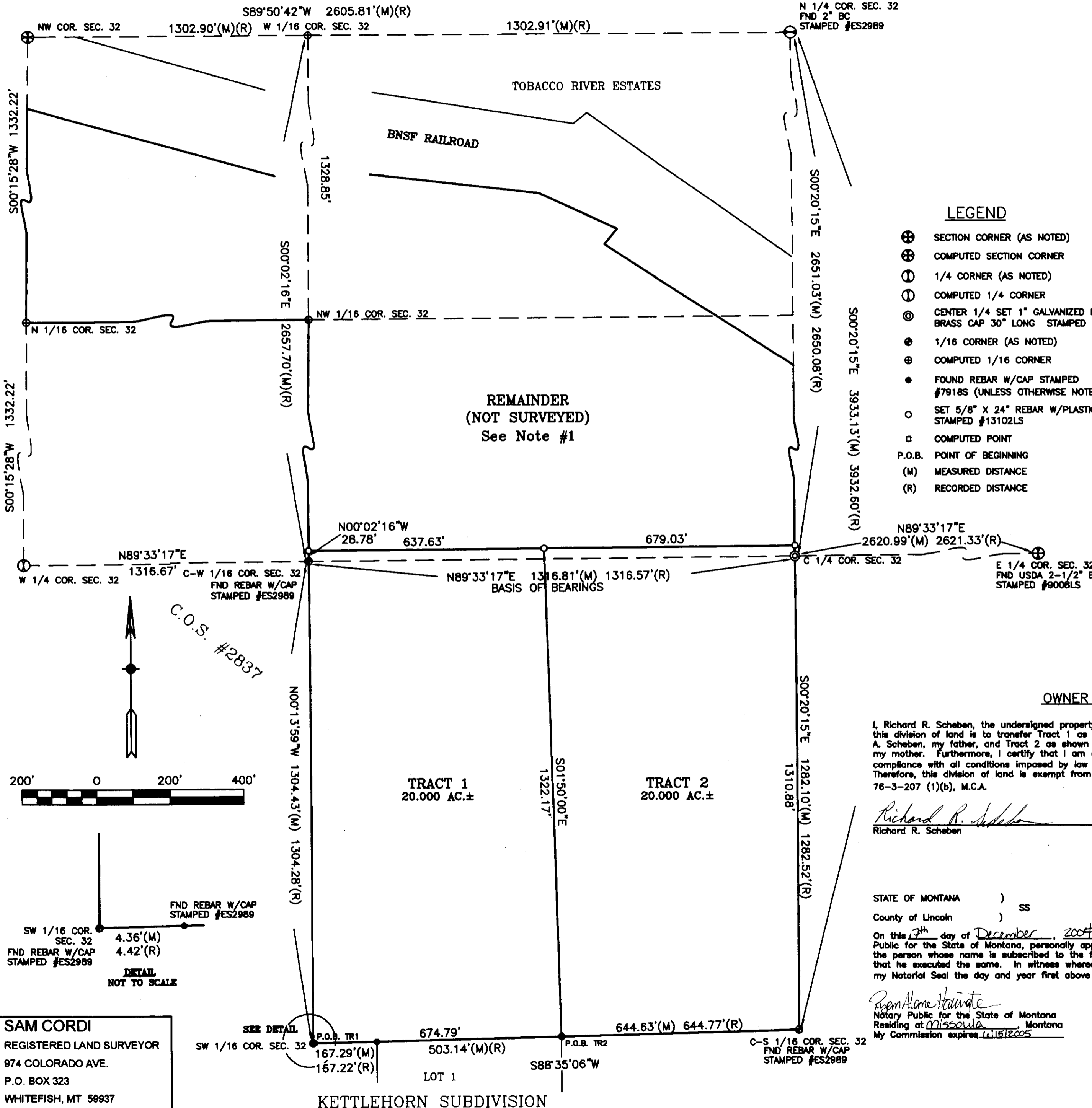

DESCRIPTIONS



TRACT 1

That portion of the Southeast one-quarter of the Northwest one-quarter (SE1/4NW1/4) and the Northeast one-quarter of the Southwest one-quarter (NE1/4SW1/4) of Section Thirty-two (32), Township Thirty-six North (T36N), Range Twenty-six West (R26W), Principal Meridian, Montana, Lincoln County, Montana, more particularly described as follows:

Beginning at the southwest corner of the Northeast one-quarter of the Southwest one-quarter (NE1/4SW1/4) of said Section Thirty-two (32); thence North00°13'50" West 1304.43 feet along the westerly boundary of said Northeast one-quarter of the Southwest one-quarter (NE1/4SW1/4) of Section Thirty-two (32) to the southwest corner of the Southeast one-quarter of the Northwest one-quarter (SE1/4NW1/4) of said Section Thirty-two (32); thence North00°02'16" West 28.78 feet along the easterly boundary of said Southeast one-quarter of the Northwest one-quarter (SE1/4NW1/4) of Section Thirty-two (32); thence North89°33'17" East 637.73 feet; thence South01°50'00" East 1322.17 feet to the southerly boundary of said Northeast one-quarter of the Southwest one-quarter (NE1/4SW1/4) of Section Thirty-two (32); thence South88°35'06" West 674.79 feet along said southerly boundary to the point of beginning and containing 20.000 acres of land, gross measure, more or less. All as shown hereon.

Subject to and together with all appurtenant easements of record.

TRACT 2

That portion of the Southeast one-quarter of the Northwest one-quarter (SE1/4NW1/4) and the Northeast one-quarter of the Southwest one-quarter (NE1/4SW1/4) of Section Thirty-two (32), Township Thirty-six North (T36N), Range Twenty-six West (R26W), Principal Meridian, Montana, Lincoln County, Montana, more particularly described as follows:

Commencing at the southwest corner of the Northeast one-quarter of the Southwest one-quarter (NE1/4SW1/4) of said Section Thirty-two (32); thence North88°35'06" East 674.79 feet along the southerly boundary of said Northeast one-quarter of the Southwest one-quarter (NE1/4SW1/4) of Section Thirty-two (32) to the TRUE POINT OF BEGINNING of the tract of land herein described; thence North01°50'00" West 1322.17 feet; thence North89°33'17" East 637.73 feet to the easterly boundary of said Southeast one-quarter of the Northwest one-quarter (SE1/4NW1/4) of Section Thirty-two (32); thence South00°20'15" East 1310.88 feet along said easterly boundary of the Southeast one-quarter of the Northwest one-quarter (SE1/4NW1/4) and along the easterly boundary of said Northeast one-quarter of the Southwest one-quarter (NE1/4SW1/4) of Section Thirty-two (32) to the southerly boundary of said Northeast one-quarter of the Southwest one-quarter (NE1/4SW1/4) of Section Thirty-two (32); thence South88°35'06" West 644.63 feet along said southerly boundary to the point of beginning and containing 20.000 acres of land, gross measure, more or less. All as shown hereon.
