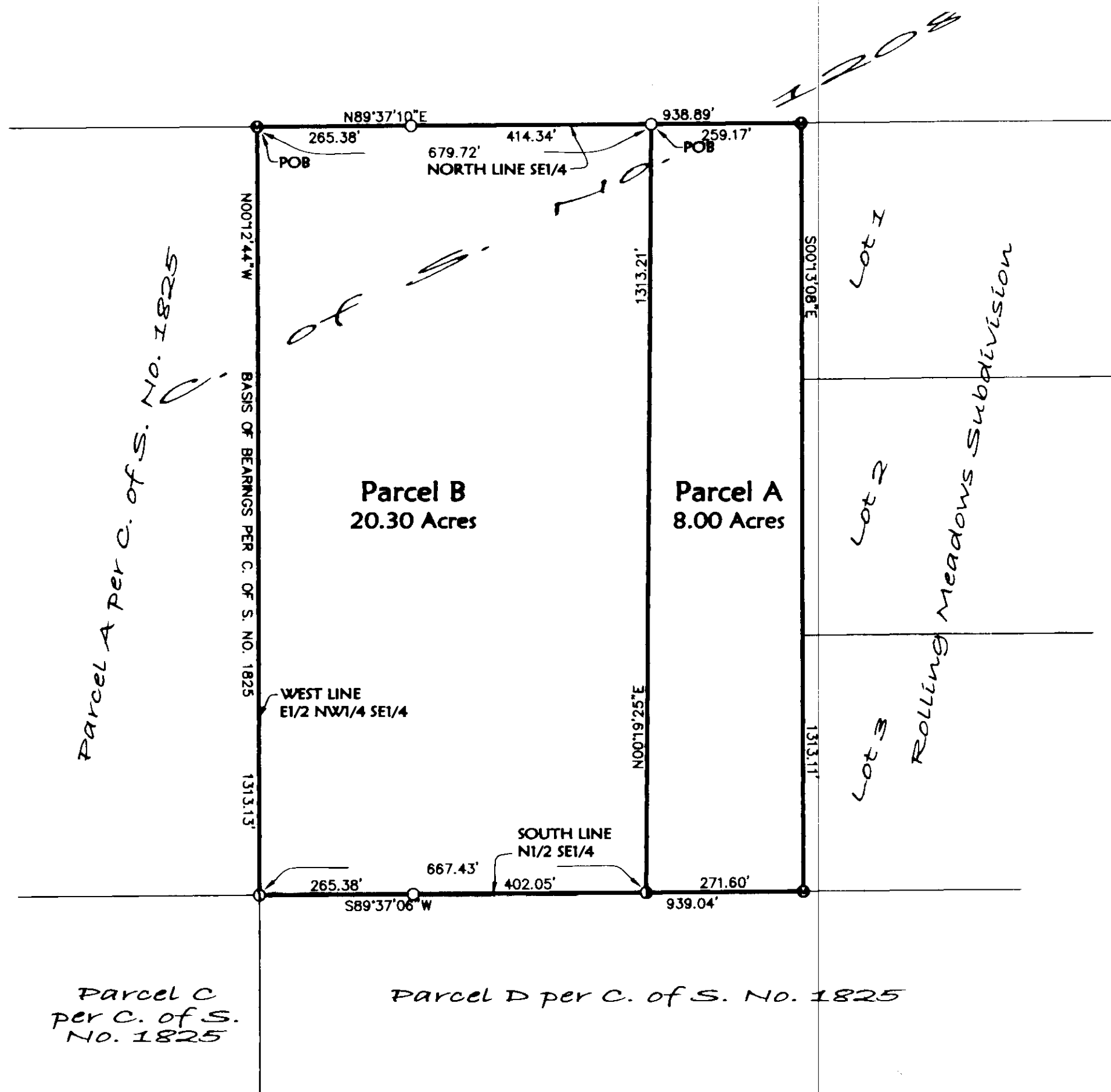
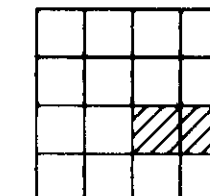

That portion of the North 1/2 of the Southeast 1/4, Section 27, Township 37 North, Range 27 West, P.M., M., Lincoln County, Montana, described as follows:
Commencing at the Northwest corner of the East 1/2 of the Northwest 1/4 of the Southeast 1/4;
Thence along the North line of the North 1/2 of the Southeast 1/4, North 89°37'10" East 679.72 feet to the Point of Beginning;
Thence continuing along said North line, North 89°37'10" East 259.17 feet;
Thence South 00°13'08" East 1313.11 feet to the South line of the North 1/2 of the Southeast 1/4;
Thence along the South line of the North 1/2 of the Southeast 1/4, South 89°37'06" West 271.60 feet;
Thence North 00°19'25" East 1313.21 feet to the Point of Beginning
containing 8.00 acres of land all as shown hereon.

That portion of the North 1/2 of the Southeast 1/4, Section 27, Township 37 North, Range 27 West, P.M., M., Lincoln County, Montana, described as follows:
Beginning at the Northwest corner of the East 1/2 of the Northwest 1/4 of the Southeast 1/4;
Thence along the North line of the North 1/2 of the Southeast 1/4, North 89°37'10" East 679.72 feet;
Thence South 00°19'25" West 1313.21 feet to the Southeast corner of the East 1/2 of the Northwest 1/4 of the Southeast 1/4;
Thence along the South and West lines of the East 1/2 of the Northwest 1/4 of the Southeast 1/4, South 89°37'06" West 667.43 feet and North 00°12'44" West 1313.13 feet to the Point of Beginning
containing 20.30 acres of land all as shown hereon.
