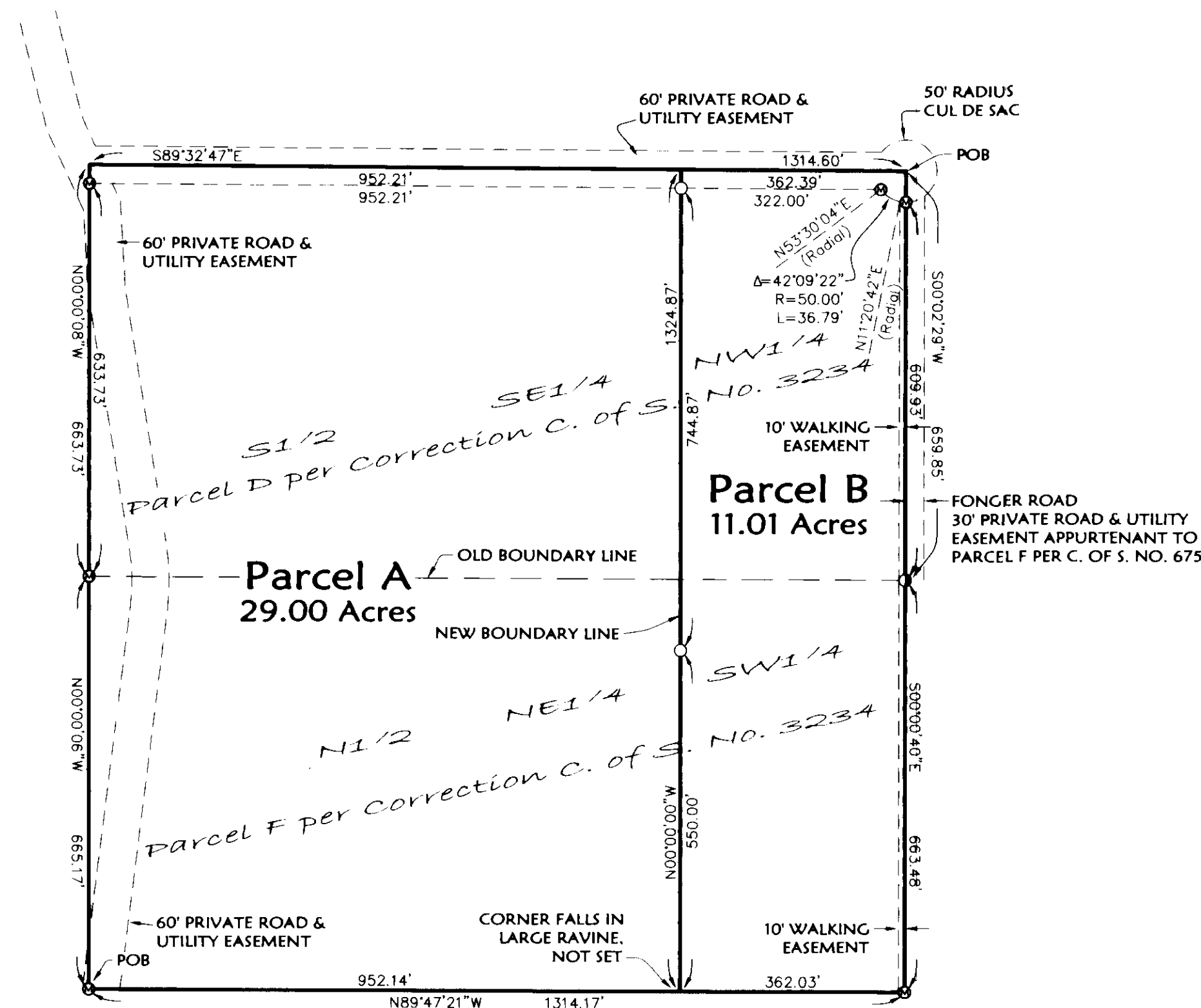
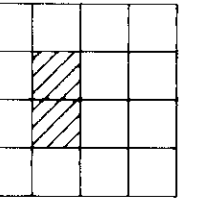

# CERTIFICATE OF SURVEY

## S1/2 SE 1/4 NW1/4 & N1/2 NE1/4 SW1/4 of Section 23, T37N R27W, P.M., M. Lincoln County, Montana



**Parcel A**  
Those portions of the South 1/2 of the Southeast 1/4 of the Northwest 1/4 and the North 1/2 of the Northeast 1/4 of the Southwest 1/4, Section 23, Township 37 North, Range 27 West, P.M., M., Lincoln County, Montana, described as follows:  
Beginning at the Southwest corner of the North 1/2 of the Northeast 1/4 of the Southwest 1/4;  
Thence along the West line of the North 1/2 of the Northeast 1/4 of the Southwest 1/4, North 00°00'06" West 665.17 feet to the Southwest corner of the South 1/2 of the Southeast 1/4 of the Northwest 1/4;  
Thence along the West and North lines of the South 1/2 of the Southeast 1/4 of the Northwest 1/4, North 00°00'08" West 663.73 feet and South 89°32'47" East 952.21 feet;  
Thence South 1324.87 feet to the South line of the North 1/2 of the Northeast 1/4 of the Southwest 1/4;  
Thence along the South line of the North 1/2 of the Northeast 1/4 of the Southwest 1/4, North 89°47'21" West 952.14 feet to the Point of Beginning containing 29.00 acres of land all as shown hereon.  
Subject to and together with easements of record.

**Parcel B**  
Those portions of the South 1/2 of the Southeast 1/4 of the Northwest 1/4 and the North 1/2 of the Northeast 1/4 of the Southwest 1/4, Section 23, Township 37 North, Range 27 West, P.M., M., Lincoln County, Montana, described as follows:  
Beginning at the Northeast corner of the South 1/2 of the Southeast 1/4 of the Northwest 1/4;  
Thence along the East line of the South 1/2 of the Southeast 1/4 of the Northwest 1/4, South 00°02'29" West 659.85 feet to the Northeast corner of the North 1/2 of the Northeast 1/4 of the Southwest 1/4;  
Thence along the East and South lines of the North 1/2 of the Northeast 1/4 of the Southwest 1/4, South 00°00'40" East 663.48 feet and North 89°47'21" West 362.03 feet;  
Thence North 1324.87 feet to the North line of the South 1/2 of the Southeast 1/4 of the Northwest 1/4;  
Thence along the North line of the South 1/2 of the Southeast 1/4 of the Northwest 1/4, South 89°32'47" East 362.39 feet to the Point of Beginning containing 11.01 acres of land all as shown hereon.  
Subject to and together with easements of record.

**Owner Certification**
