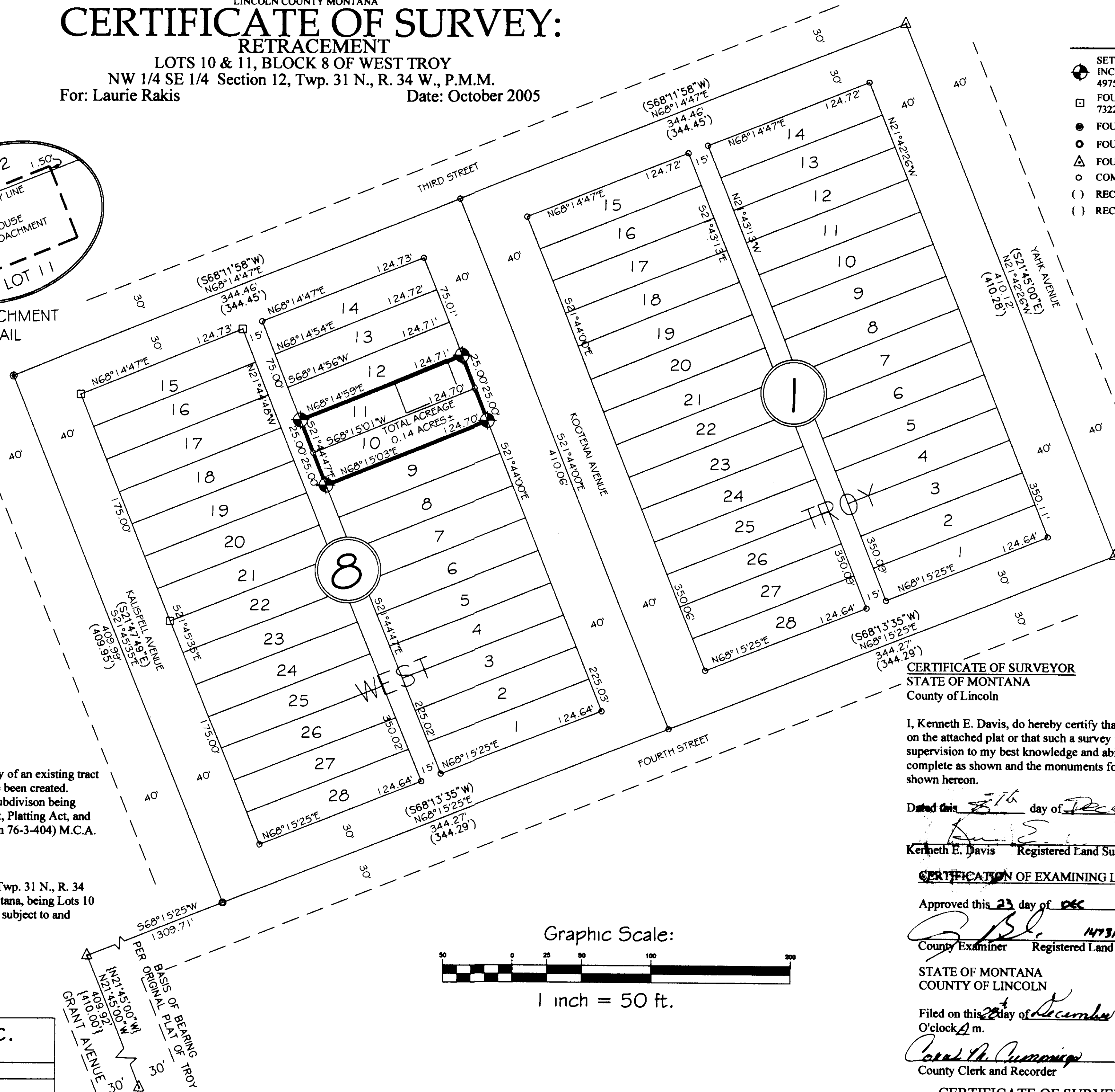
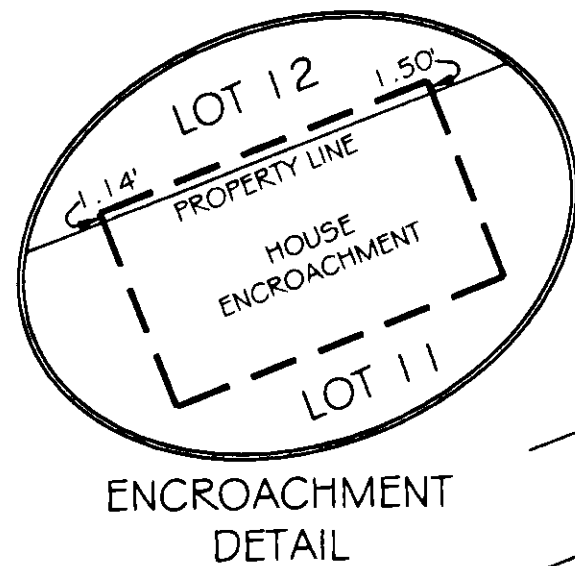

**PURPOSE OF SURVEY/EXEMPTION**

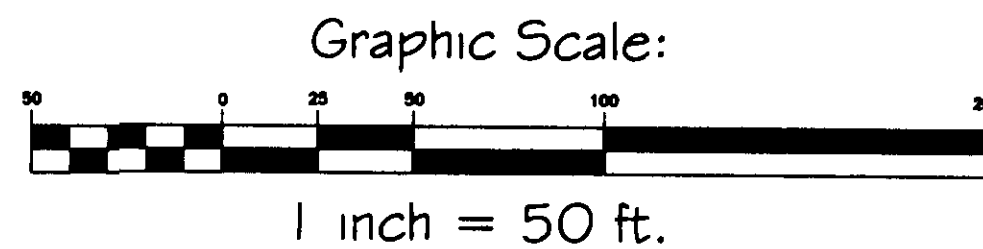
