Beginning at a 1 inch dia. rebar which marks the southeast corner of C.O.S. 646; thence, N00°00'21"E 657.70 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N48°32'14"E 426.83 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S having a radial bearing of S49°45'20"W and located on the west right of way of Lake Creek Road a 60.00 foot county roadway; thence on the arc of a curve to a the right, a distance of 17.31 feet, turning through a delta angle of 01°40'00", and having a radius of 595.00 feet, to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S38°34'39"E 313.32 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence on the arc of a curve to the right, a distance of 102.52 feet, turning through a delta angle of 01°41'34", and having a radius of 3470.00 feet, to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S36°53'05"E 99.80 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence on the arc of a curve to the right, a distance of 568.86 feet, turning through a delta angle of 25°39'51", and having a radius of 1270.00 feet, to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence leaving said right of way, \$89°36'40"W 878.87 feet to the point of beginning.

The aforedescribed Parcel B contains 13.01 acres more or less and is subject to and together with all appurtenant easements of record.

## **EXEMPTIONS**

Parcel A is exempt from sanitation review by the D.E.Q. pursuant to ARM 17.36.605(2)(b)(i)&(ii) as a parcel that has no existing facilities for water supply, wastewater disposal, or solid waste disposal other than those that were previously approved by the reviewing authority under Title 76, chapter 4, part 1, M.C.A. or that were exempt from such review because no new facilities will be constructed on the parcel and the division of land will not cause approved facilities to violate any conditions of approval, and will not cause exempt facilities to violate any condition of approval.

Parcel B is exempt from sanitation review by the D.E.Q. pursuant to M.C.A. 76-4-125(e)(ii) as a remainder of an original tract created by segregating a parcel from the tract for purpose of transfer because the remainder is 1 acre or larger and has an individual sewage system that was constructed prior to April 29, 1993, and if required when installed, was approved pursuant to local regulations or M.C.A. Title 76, Chapter 4,
