

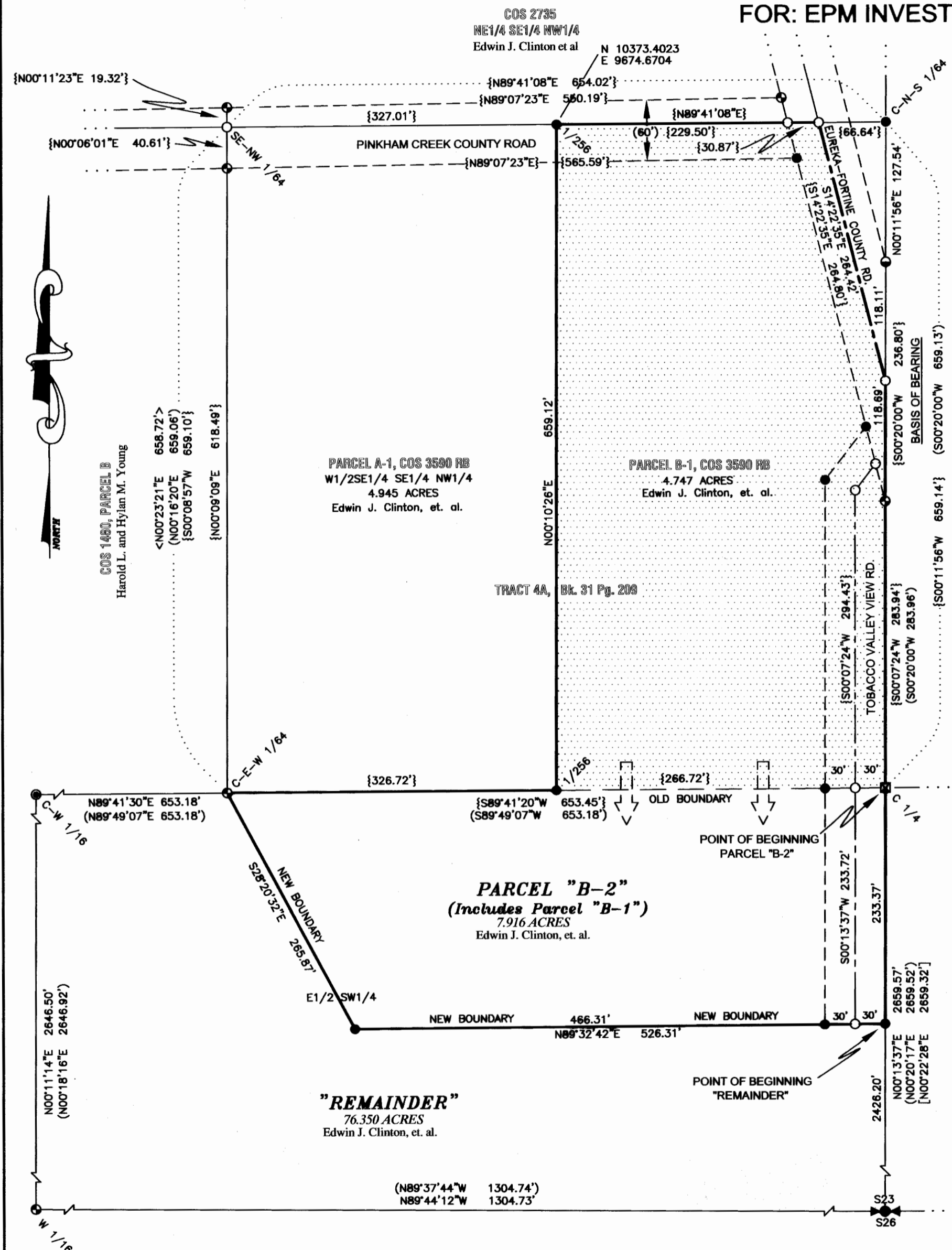

### DESCRIPTION PARCEL "B-2"

An irregular tract of land southerly from Eureka, Montana, Lincoln County, and lying in the SE 1/4 SE 1/4 NW 1/4, Section 23, T36N, R27W, PM, MT, and more particularly described as follows:

Commencing at the C 1/4 corner, said Section, a 5/8 inch diameter rebar alongside a railroad tie being also the TRUE POINT OF BEGINNING; Thence along mid line, said section and easterly easement limits of "Tobacco Valley View Road", S00°13'37"W, 233.37 feet to a 5/8 inch diameter rebar with plastic cap marked HUGHES, 7322LS; Thence S89°32'42"W, 30.00 feet to the centerline of said easement, an unmarked point; thence continue westerly along said line, a distance of 30.00 feet to the westerly limits of said easement, a 5/8 inch diameter rebar with plastic cap marked HUGHES, 7322LS; thence continue westerly along said line, a distance of 466.31 feet to a 5/8 inch diameter rebar with plastic cap marked HUGHES, 7322LS; Thence N28°20'32"W, 265.87 feet to the C-E-W 1/64th corner, a 5/8 inch diameter rebar, plastic cap marked KED, 4975S; Thence along 1/16th line, N89°41'20"E, 326.72 feet to a 1/256 corner, a 5/8 inch diameter rebar with plastic cap marked Hughes, 7322LS; thence northerly along a subdivision line, N00°10'26"E, 659.12 feet to a 1/256 corner, a 5/8 inch diameter rebar with plastic cap marked Hughes, 7322LS; thence northerly along a subdivision line, N00°10'26"E, 659.12 feet to the centerline of said road, an unmarked point; thence continue easterly along said line, 30.87 feet to the centerline of said road, an unmarked point; thence continue easterly along said line, 30.87 feet to an unmarked point; thence southerly along the section centerline, S00°20'00"W, 118.69 feet to the westerly limits of said road, a 5/8 inch diameter rebar with plastic cap marked KED, 4975S; thence southerly along said section centerline and easterly limits of "Tobacco Valley View Road", S00°07'24"W, 283.94 feet to the True Point of Beginning, containing 7.916 acres. Subject to and together with all appurtenant easements of record.

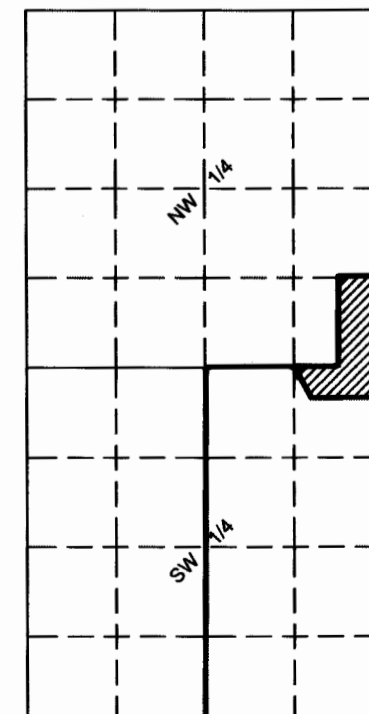

Commencing at the C 1/4 Corner of said section, a 5/8 inch diameter rebar alongside a railroad tie; Thence along section mid line, S00°13'37"W, 233.37 feet to a 5/8 inch diameter rebar with plastic cap marked HUGHES, 7322LS to the POINT OF BEGINNING; Thence continue southerly along said line, a distance of 2,426.20 feet to the quarter corner between sections 23 and 26, a 2 1/2 inch diameter iron pipe with brass cap marked BLM; Thence along said section line, N89°44'12"W, 1,304.73 feet to the W 1/16th corner between said sections, a 5/8 inch diameter rebar, plastic cap marked KED, 4975S; Thence along 1/16th line, N00°11'14"E, 2,646.50 feet to the C-W 1/16th corner, an iron pipe with 2 inch diameter brass cap; Thence along 1/16th line, N89°41'30"E, 653.18 feet to the C-E-W 1/64th corner, a 5/8 inch diameter rebar, plastic cap marked KED, 4975S; Thence along "New Boundary", S28°20'32"E, 265.87 feet to a 5/8 inch diameter rebar with plastic cap marked HUGHES, 7322LS; Thence along "New Boundary", N89°32'42"E, 466.31 feet, intersecting the westerly limits of "Tobacco Valley View Road", a 5/8 inch diameter rebar with plastic cap marked HUGHES, 7322LS; thence continue easterly along said line, a distance of 30.00 feet to the centerline of said road, an unmarked point; thence continue easterly along said line, a distance of 30.00 feet to the easterly limits of said road and the POINT OF BEGINNING, containing 76.350 acres.
