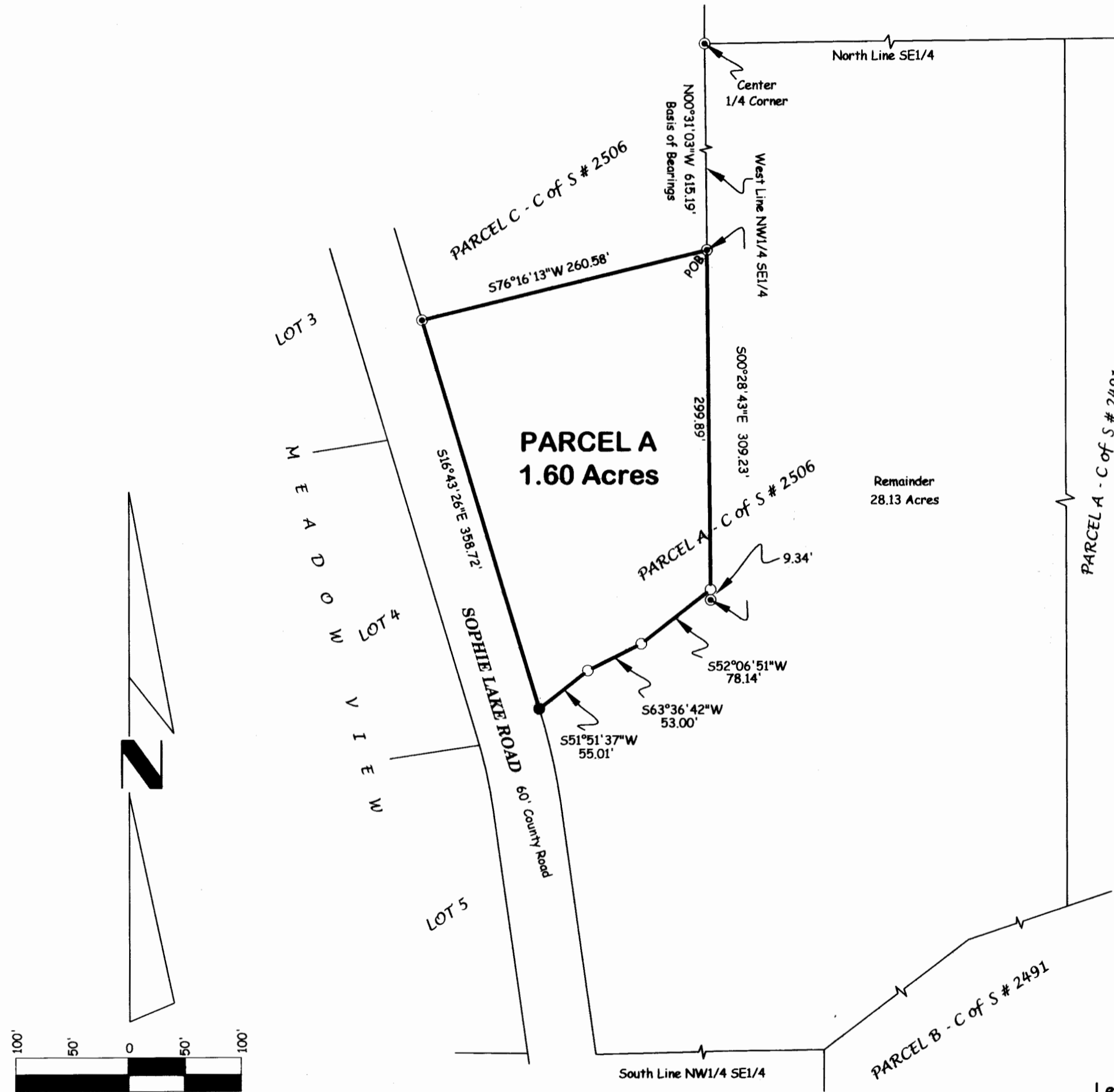

 Thence South 63°36'42" West 53.00 feet;  
 Thence South 51°51'37" West 55.01 feet to the Easterly line of Sophie Lake Road;  
 Thence along the Easterly line of the road, North 16°43'26" West 358.72 feet;
