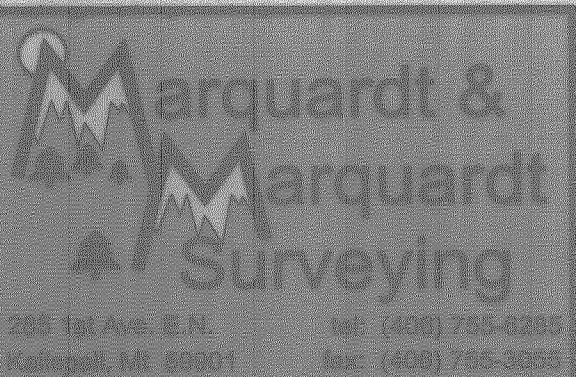

That portion of the Southwest 1/4, Section 7, Township 34 North, Range 25 West, P.M., M., Lincoln County, Montana, described as follows:

Beginning at the West 1/4 corner, Section 7;

Thence along the North line of the Southwest 1/4, North 89°53'44" East 1190.33 feet to the Westerly line of the Mission Mountain Railroad right of way;

Thence along the Westerly line of the railroad right of way, South 34°26'48" East 1318.49 to the East line of the West 1/2 of the Northeast 1/4 of the Southwest 1/4;

Thence along the East line of the West 1/2 of the Northeast 1/4 of the Southwest 1/4, South 00°02'15" East

Northeast corner of the Northwest 1/4 of the Southeast 1/4;
