## **DESCRIPTION OF TRACT 2-4**

A tract of land in the Yaak Valley of Lincoln County Montana, being a part of H.E.S. 274 (Plat No. 2304), located in unsurveyed Section 2, Twp. 35 N., R. 32 W., P.M.M., containing 1.90 acres more or less and more particularly described as follows:

Beginning at a 5/8 inch dia. rebar capped K.E.D. 4975-S which marks the northeast corner of Tract 2-3 per C.O.S. 2939 and located on the south right-of-way line of Montana State Highway No. 508; thence, N66°55'29"E 98.69 feet along said south right-of-way line, to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S59°57'41"E 481.66 feet to a 1/2 inch dia. bare rebar located on the northerly bank of the Yaak River; thence downstream, S31°12'39"W 37.60 feet to a computed point; thence, S33°56'17"W 200.00 feet to a computed point; thence, N43°14'18"W 20.00 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S located on the northerly bank of said Yaak River; thence continuing, N43°14'18"W 529.78 feet to the point of beginning.

The aforedescribed Tract 2-3 contains 1.90 acres more or less and is subject to and together with all appurtenant easements of record.

## PURPOSE OF SURVEY

The purpose of this survey is to retrace the exterior boundaries of existing tracts of record and that no new parcels have been created; therefore, this survey is exempt from review as a subdivision being completed pursuant to 76-3-404 M.C.A.
