PURPOSE OF SURVEY

The purpose of this survey is the retracement of existing Property lines, establish obliterated or lost corners. Therefore no division of land is hereby created and survey is exempt from review as a subdivision under the Montana Subdivision and Platting Act, Section 76-3-404, MCA.

METHOD OF SURVEY

A total station with data collector with closed traverse procedures was used to tie previously set controlling monuments by John Damon, June 2007.

BASIS OF BEARING

The basis of bearing for this survey is N89°57'07"E, as shown on Plat No. 2556, between a 3/4 inch diameter unmarked rebar and 1/2 inch diameter rebar, marking the North boundary of Lot 37.

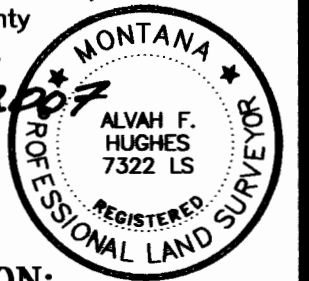

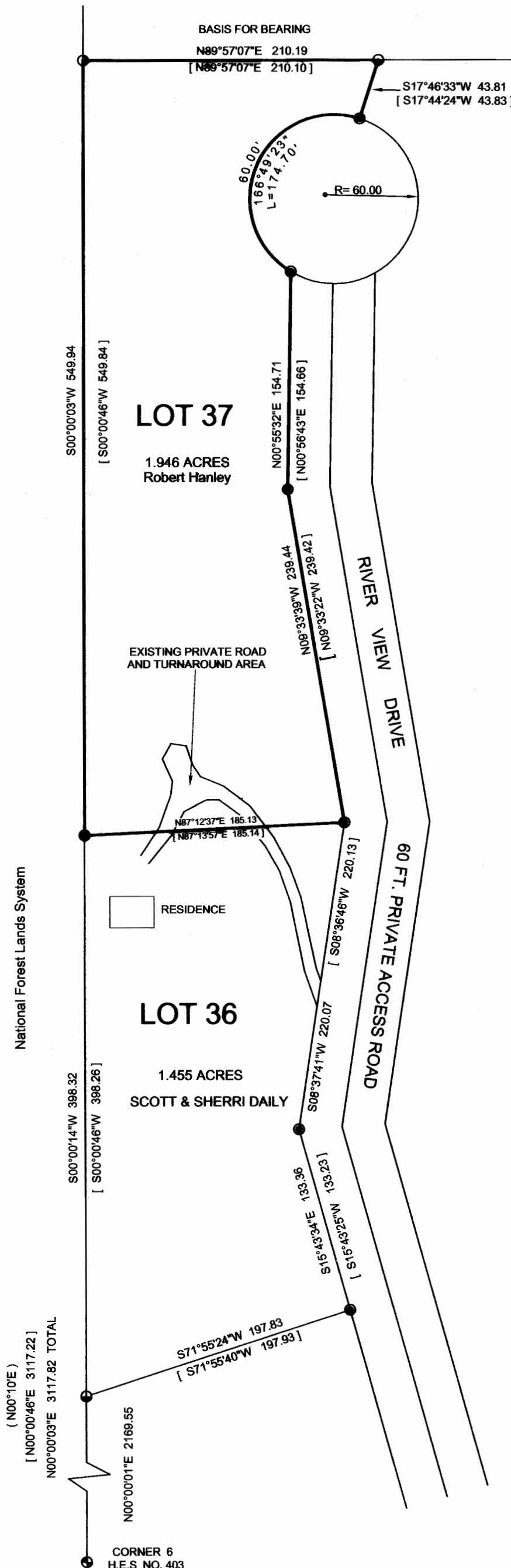

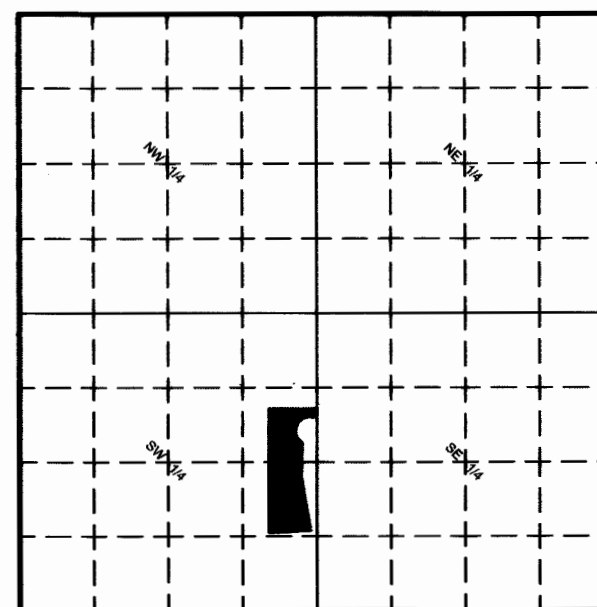


LEGAL DESCRIPTION LOT 37, BLOCK 1
