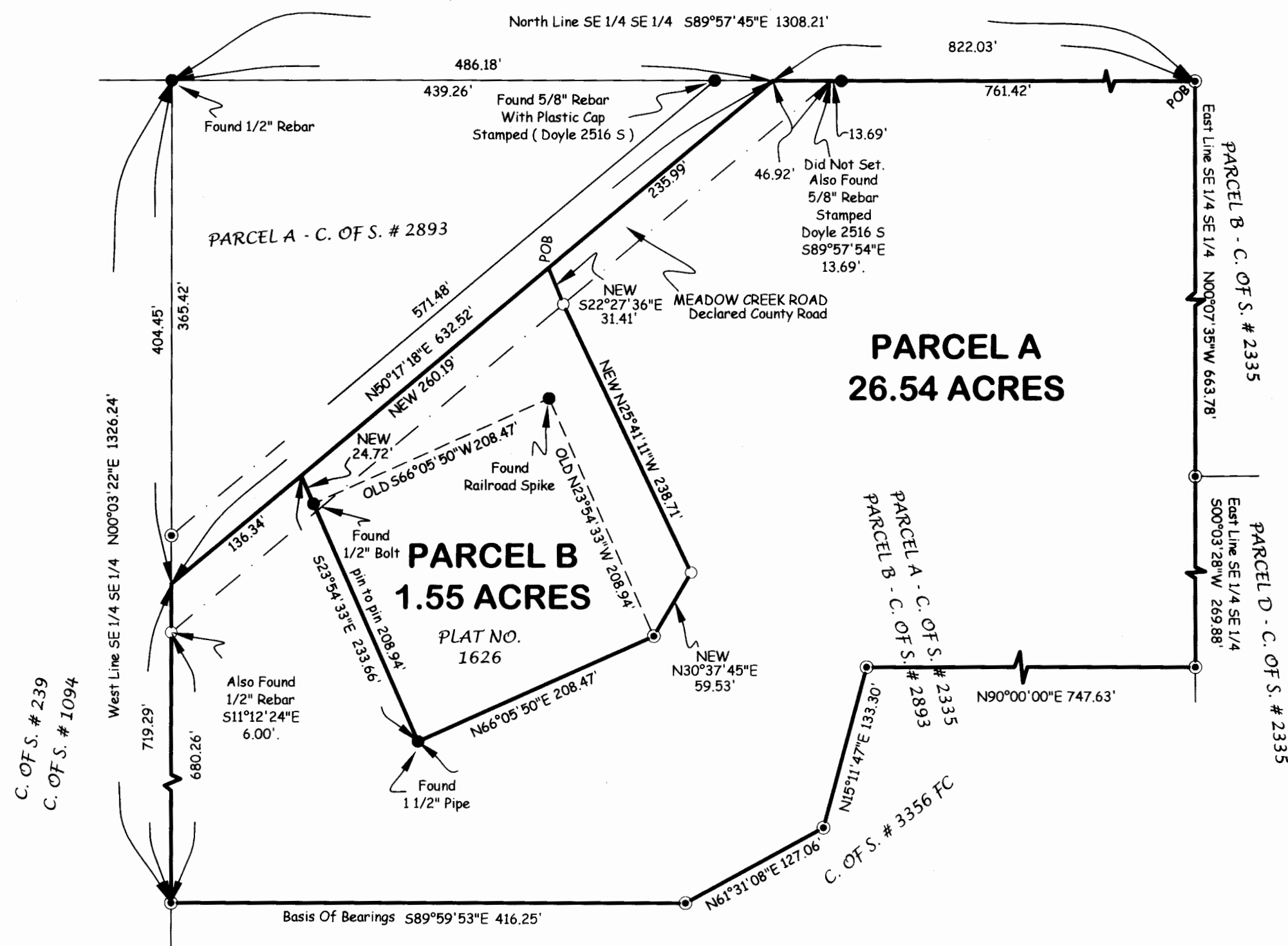

Certificate of Survey

SE1/4 Section 28, T35N R26W P.M., M. Lincoln County, Montana



Parcel A
That portion of the Southeast 1/4 of the Southeast 1/4, Section 28, Township 35 North, Range 26 West, P.M., M., Lincoln County, Montana, described as follows:
Beginning at the Northeast corner of the Southeast 1/4 of the Southeast 1/4;
Thence along the East line of the Southeast 1/4 of the Southeast 1/4, South 00°03'28" East 663.78 feet and South 00°03'28" West 269.88 feet;
Thence West 747.63 feet;
Thence South 15°11'47" West 133.30 feet;
Thence South 61°31'08" East 127.06 feet;
Thence North 89°59'53" West 416.25 feet to the West line of the Southeast 1/4 of the Southeast 1/4;
Thence along the West line of the Southeast 1/4 of the Southeast 1/4, North 00°03'22" East 719.29 feet to the centerline of Meadow Creek Road;
Thence along the centerline of the road, North 50°17'18" East 136.34 feet;
Thence South 23°54'33" East 233.66 feet;
Thence North 66°05'50" East 208.47 feet;
Thence North 30°37'45" East 59.53 feet;
Thence North 25°41'11" West 238.71 feet;
Thence North 22°27'36" West 31.41 feet to the centerline of Meadow Creek Road;
Thence along the centerline of the road, North 50°17'18" East 235.99 feet to the North line of the Southeast 1/4 of the Southeast 1/4;
Thence along the North line of the Southeast 1/4 of the Southeast 1/4, South 89°57'45" East 822.03 feet to the Point of Beginning containing 26.54 acres of land all as shown hereon.
Subject to and together with easements of record.
Subject to County Road right of way as shown hereon.

Parcel B
That portion of the Southeast 1/4 of the Southeast 1/4, Section 28, Township 35 North, Range 26 West, P.M., M., Lincoln County, Montana, described as follows:
Commencing at the Northeast corner of the Southeast 1/4 of the Southeast 1/4;
Thence along the North line of the Southeast 1/4 of the Southeast 1/4, North 89°57'45" West 822.03 feet to the centerline of Meadow Creek Road;
Thence along the centerline of the road, South 50°17'18" West 235.99 feet to the Point of Beginning;
Thence continuing along the centerline of the road South 50°17'18" West 260.19 feet;
Thence South 23°54'33" East 233.66 feet;
Thence North 66°05'50" East 208.47 feet;
Thence North 30°37'45" East 59.53 feet;
Thence North 25°41'11" West 238.71 feet;
Thence North 22°27'36" West 31.41 feet to the Point of Beginning containing 1.55 acres of land all as shown hereon.
Subject to and together with easements of record.
