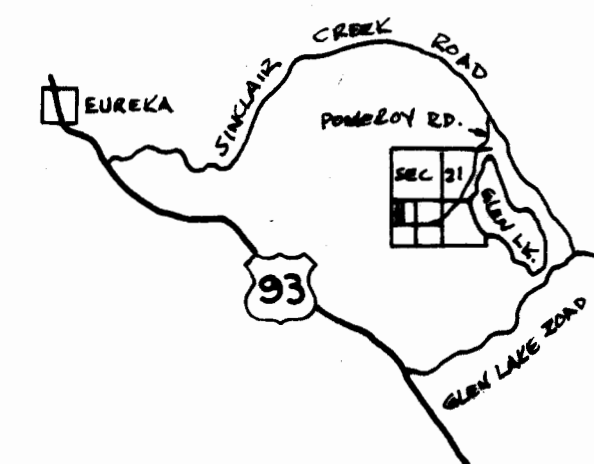

VICINITY MAP 1" = 2 MILES

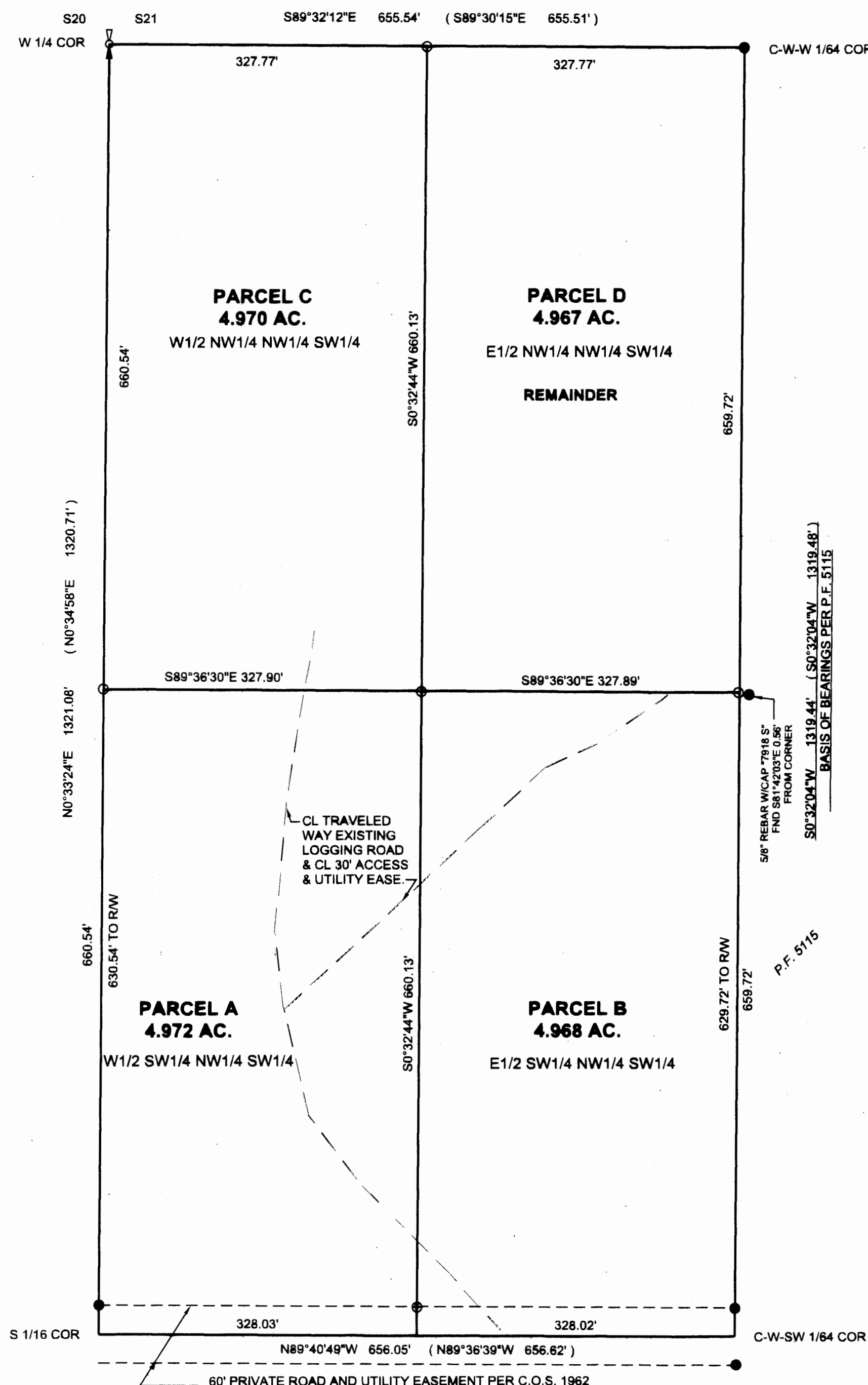

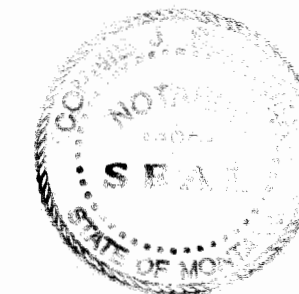

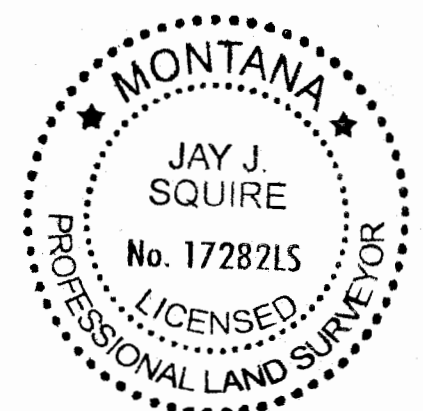
