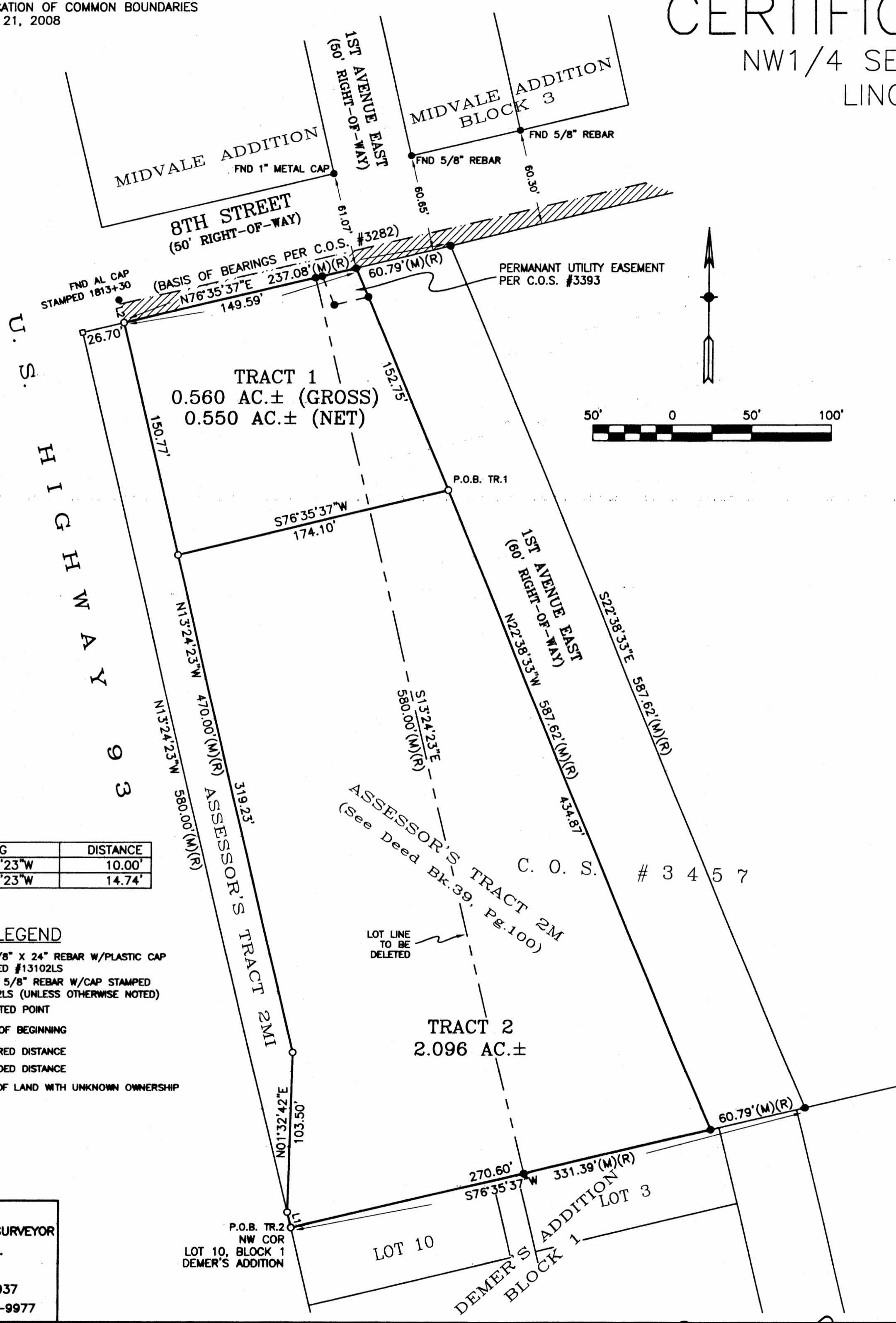

TRACT 1 DESCRIPTION
 That portion of the Southeast one-quarter of the Northwest one-quarter (SE1/4NW1/4) of Section Fourteen (14), Township Thirty-six North (T36N), Range Twenty-seven West (R27W), Principal Meridian, Montana, Lincoln County, Montana, more particularly described as follows:
 Commencing at the Northwest corner of Lot Ten (10) of Block One (1) of Demer's Addition to Eureka, Montana, according to the map or plat thereof on file in the office of the Clerk and Recorder of Lincoln County, Montana; thence North76°35'37"East 270.60 feet along the northerly boundary of said Block One (1) of Demer's Addition to the westerly right of way of a 60-foot wide public road (First Avenue East); thence North22°38'33"West 434.87 feet along said westerly right of way to the TRUE POINT OF BEGINNING of the tract of land herein described; thence South76°35'37"West 174.10 feet to the easterly right of way U.S. Highway No. 93; thence North13°24'23"West 150.77 feet along said easterly right of way; thence North76°35'37"East 149.59 feet to the westerly right of way of said 60-foot wide public road (First Avenue East); thence South22°38'33"East 152.75 feet along said westerly right of way to the point of beginning and containing 0.560 acres of land, gross measure, more or less. All as shown hereon.

 That portion of the Southeast one-quarter of the Northwest one-quarter (SE1/4NW1/4) of Section Fourteen (14), Township Thirty-six North (T36N), Range Twenty-seven West (R27W), Principal Meridian, Montana, Lincoln County, Montana, more particularly described as follows:
 Beginning at the Northwest corner of Lot Ten (10) of Block One (1) of Demer's Addition to Eureka, Montana, said point also being on the easterly right of way of U.S. Highway No. 93; thence the following three (3) courses and distances along said easterly right of way: North13°24'23"West 10.00 feet, North01°32'42"East 103.50 feet, North13°24'23"West 319.23 feet; thence North76°35'37"East 174.10 feet to the westerly right of way of a 60-foot wide public road (First Avenue East); thence South22°38'33"East 434.87 feet along said westerly right of way to the northerly boundary of Block One (1) of said Demer's Addition; thence South76°35'37"West 270.60 feet along said northerly boundary to the point of beginning and containing 2.096 acres of land, gross measure, more or less.
