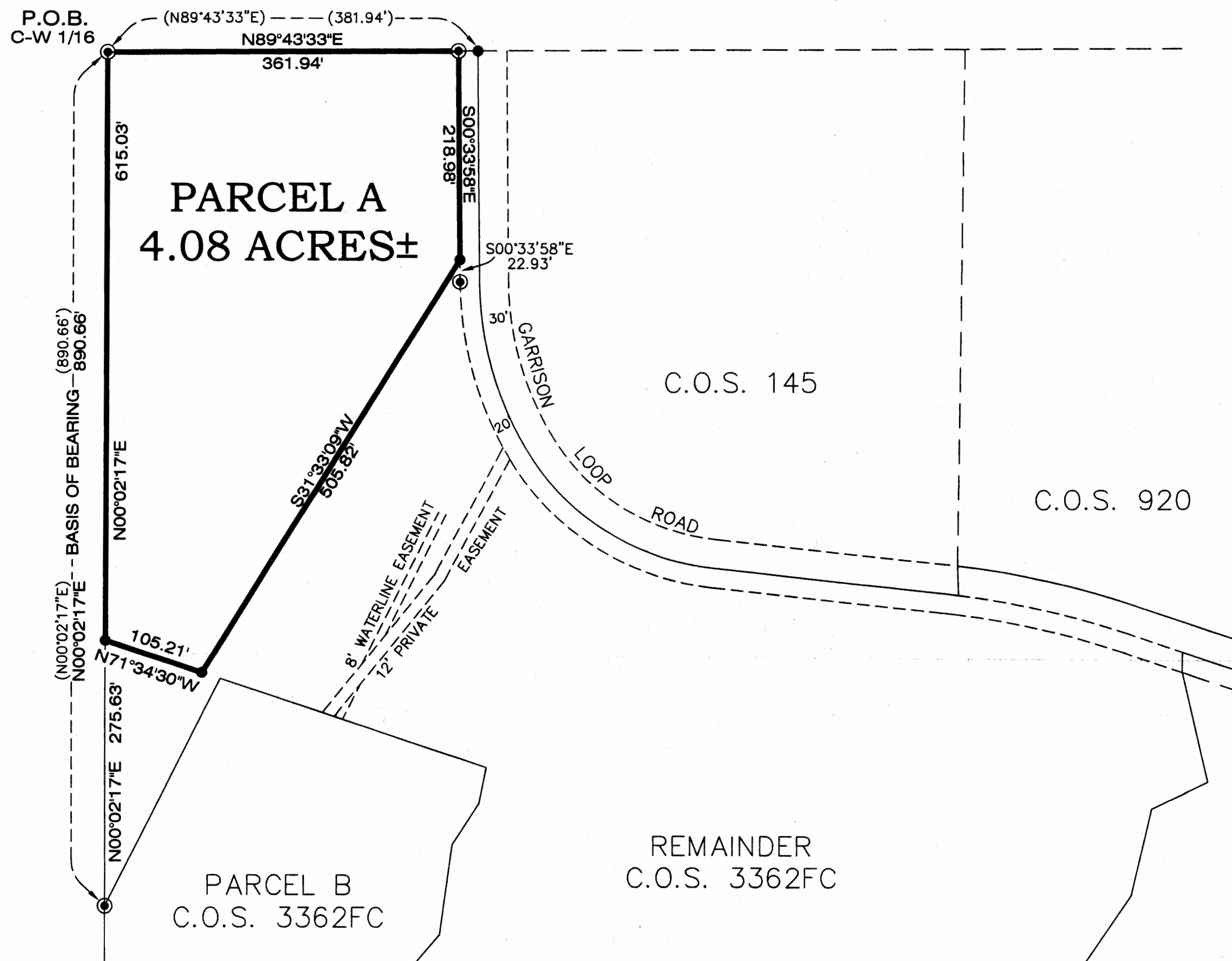

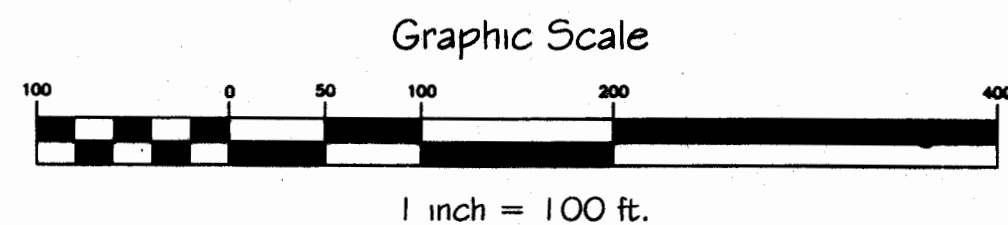

DESCRIPTION OF PARCEL A (MORTGAGE EXEMPTION)

A tract of land near Troy, in Lincoln County Montana, lying in the NE 1/4 SW 1/4 of Section 13 Twp. 31 N., R. 34 W., P.M.M. containing 4.08 acres more or less and more particularly described as follows:

Beginning at a 5/8 inch dia. rebar capped K.E.D. 4975-S which marks the C-W 1/16th of Section 13, Twp. 31 N., R. 34 W., P.M.M.; thence, N89°43'33"E 361.94 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S00°33'58"E 218.98 feet to a computed point; thence, S31°33'09"W 505.82 feet to a computed point; thence, N71°34'30"W 105.21 feet to a computed point; thence, N00°02'17"E 615.03 feet to the point of beginning.

The aforescribed Parcel A contains 4.08 acres more or less and is to be used for mortgage purposes only.
