



### LEGAL DESCRIPTION "PARCEL A, COS 2683"

An irregular tract of land, southeasterly from Eureka, Montana, in Lincoln County and in the S1/2 NE1/4 NW1/4, Section 25, T.36N., R.27W., P.M.,MT., more particularly described as:  
Commencing at the NW 1/16th corner Section 25, a 5/8 inch diameter rebar with a plastic cap marked 7328S and being the TRUE POINT OF BEGINNING;  
Thence along a 1/16th subdivision line bearing N01°09'05"E, 653.92 feet to a 5/8 inch diameter rebar with plastic cap marked 7328S, lying on the southerly right-of-way limits of Burlington Northern-Santa Fe railroad; Thence along said r/w limits, S56°44'07"E, 80.16 feet to a set 5/8 inch diameter rebar with a plastic cap marked HUGHES 7322LS; Thence continuing along said r/w limits, S57°16'57"E, 1,171.81 feet to a 5/8 inch diameter rebar with plastic cap marked 7328S and lying on a 1/16th subdivision line; Thence along said 1/16th subdivision line, N88°44'06"W, 399.06 feet to the C-E-NW 1/64th corner, a 5/8 inch diameter rebar with plastic cap marked 7328S;  
Thence continuing along said 1/16th subdivision line, N88°44'06"W, 667.26 feet to a 5/8 inch diameter rebar with a plastic cap marked 7328S and the TRUE POINT OF BEGINNING, containing 7.993 acres.  
Subject to and together with all appurtenant easements of record.


### LEGAL DESCRIPTION "PARCEL A-1"

An irregular tract of land, southeasterly from Eureka, Montana, in Lincoln County and in the W1/2 SE1/4 NW1/4, Section 25, T.36N., R.27W., P.M.,MT., more particularly described as:  
Commencing at the NW 1/16th corner Section 25, a 5/8 inch diameter rebar with a plastic cap marked 7328S, and being the TRUE POINT OF BEGINNING;  
Thence along a 1/16th subdivision line, S88°44'06"E, 667.26 feet to the C-E-NW 1/64th corner of said Section 25, a 5/8 inch diameter rebar with a plastic cap marked 7328S; Thence along a 1/16th subdivision line, S01°00'53"W, 1,274.76 feet to a set 5/8 inch diameter rebar with a plastic cap marked HUGHES, 7322LS and lying on the northerly right-of-way limits of the "Tobacco Road", otherwise known as "Old Highway", 60 foot wide county road; Thence along said r/w limits, S89°52'43"W, 166.58 feet to a set 5/8 inch diameter rebar with a plastic cap marked HUGHES, 7322LS and the point of curvature of a 411.07 foot radius curve to the right, a delta angle of 42°47'08"; Thence westerly along the arc of said curve, a length of 306.97 feet to a set 5/8 inch diameter rebar with a plastic cap marked HUGHES, 7322LS; Thence continuing along said r/w limits, N48°15'53"W, 290.81 feet to a set 5/8 inch diameter rebar with a plastic cap marked HUGHES 7322LS and lying on a 1/16th subdivision line; Thence along said 1/16th line, N01°04'30"E, 987.44 feet to a 5/8 inch diameter rebar with plastic cap marked 7328S and the TRUE POINT OF BEGINNING containing 18.403 acres. INCLUDING PARCEL A, herein described, containing 7.993 acres for a total combined acreage of 26.396 acres.  
Subject to and together with all appurtenant easements of record.

### LEGAL DESCRIPTION "PARCEL 1DB, COS 3035"

An irregular tract of land, southeasterly from Eureka, Montana, in Lincoln County and in the W1/2 SE1/4 NW1/4, Section 25, T.36N., R.27W., P.M.,MT., more particularly described as:  
Commencing at a 3/4 inch diameter aluminum rod with cap marked 900BLS, and being the TRUE POINT OF BEGINNING; Thence along a 1/16th subdivision line, N01°04'30"E, 251.18 feet to a set 5/8 inch diameter rebar with a plastic cap marked HUGHES 7322LS, lying on the southerly right-of-way limits of the "Tobacco Road", otherwise known as "Old Highway", a 60 foot county road; Thence along said r/w limits, S48°15'53"E, 238.31 feet to a 2 inch diameter iron pipe with cap marked 270ES and the point of curvature of 471.07 feet radius non-tangent curve to the left, through a delta angle of 24°22'25", an arc length of 200.39 feet to a 1/16th subdivision line to a set 5/8 inch diameter rebar with a plastic cap marked HUGHES 7322LS; Thence along said 1/16th line, N88°38'38"W, 354.05 feet to a 3/4 inch diameter aluminum rod with cap marked 900BLS and the TRUE POINT OF BEGINNING, containing 0.882 acres.

The basis of bearing for this survey is S88°41'45"E, as shown on COS No. 521, between the CW 1/16th corner, Section 25, a 3 1/4 inch diameter aluminum cap marked 900BLS and the C 1/4 corner, Section 25, a 2 inch diameter brass cap marked 270ES.
