

DESCRIPTION OF TRACT 1

Beginning at a 5/8 inch dia. rebar capped Goacher 7318-S which marks the C 1/4 of Section 8, Twp. 33 N., R. 34 W., P.M.M.; thence, N00°08'44"E 1324.55 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S which marks the C-N 1/16th of said Section 8; thence, S89°38'29"E 611.44 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S00°07'57"W 662.20 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S89°38'54"E 100.00 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S00°07'57"W 662.19 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N89°39'19"W 50.00 feet to a computed point which marks the southeast corner of the W 1/2 SW 1/4 NE 1/4, of said Section 8; thence continuing, N89°39'19"W 661.73 feet to the point of beginning.


