PURPOSE OF SURVEY

The purpose of this survey is the retracement of record parcels of land; establishment of obliterated corners, and mark property boundaries. Therefore, no division of land is hereby created and is exempt from review as a subdivision pursuant to Section 76-3-404 MCA.

METHOD OF SURVEY

A Nikon total station instrument and data collector were used with closed traverse procedures to tie previously set controlling corners in June, 2009 by John Damon and Byron Sanderson.

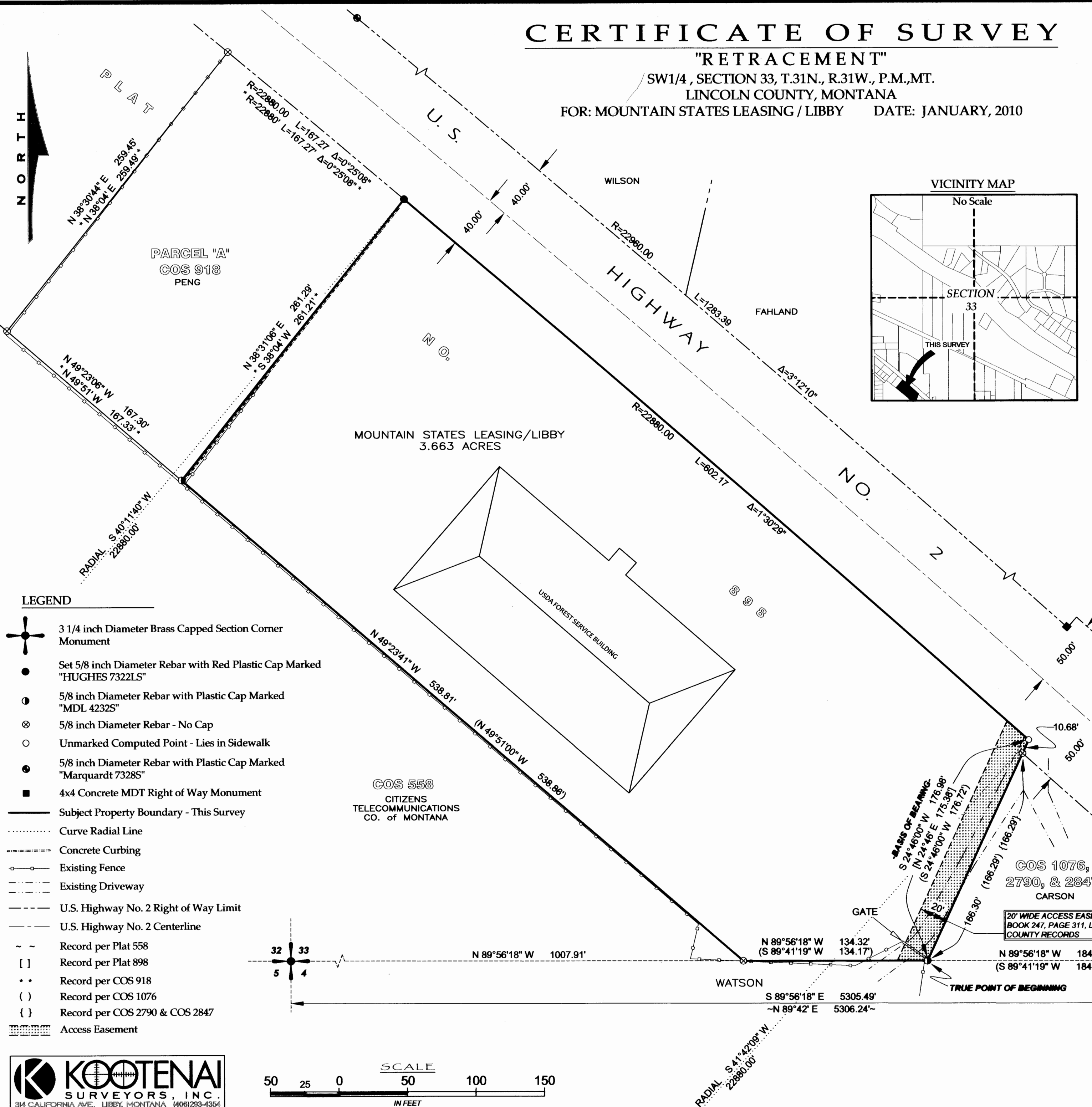
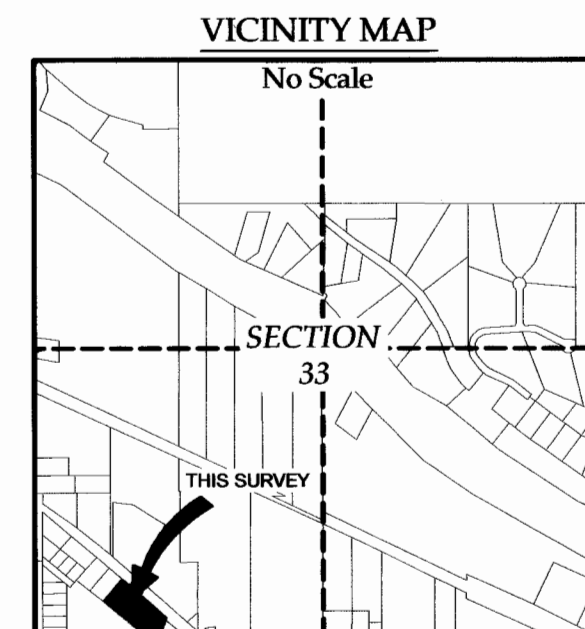
LEGAL DESCRIPTION - MOUNTAIN STATES LEASING/LIBBY PROPERTY

An irregular tract of land lying northwesterly from Libby, Montana, Lincoln County in Section 33, T31N., R31W., P.M., MT., and more particularly described as:

Commencing at the section corner common to Sections 32, 33, 4, and 5, a 3 1/4 inch diameter BLM brass capped monument; Thence S89°56'18"E, 1142.23 feet to a 5/8 inch diameter rebar with a plastic cap marked MDL, 4232S, lying on the south line of said Section 33, and the TRUE POINT OF BEGINNING; Thence along said south Section line N89°56'18"W, 134.32 feet to a 5/8 inch diameter rebar with no cap; Thence N49°23'41"W, 538.81 feet to a 5/8 inch diameter rebar with a plastic cap marked MDL 4232S; Thence N38°31'06"E, 261.29 feet to the southerly right of way limit of U.S. Highway No. 2, a non-tangent curve with center being S40°11'40"W, 22,880.00 feet radial distance and a set 5/8 inch diameter rebar with a red plastic cap marked Hughes, 7322LS; Thence along said curve of said right of way limit an arc distance of 602.17 feet to an unmarked computed point; Thence S24°46'00"W, 10.68 feet along said right of way limit to a 5/8 inch diameter rebar with no cap; Thence S24°46'00"W, 166.30 feet to a 5/8 inch diameter rebar with a plastic cap marked MDL, 4232S lying on the south line of said Section 33, and the TRUE POINT OF BEGINNING, containing 3.663 acres. Subject to a 20 foot wide access easement per book 247, page 311, Lincoln County Records, and together with all other appurtenant easements of record.

BASIS OF BEARING

The basis of bearing for this survey is S24°46'00"W, between a 5/8 inch diameter rebar with a plastic cap marked "MDL 4232S" and a 5/8 inch diameter rebar per COS No. 1076, Lincoln County records.
