SURVEYOR'S NOTE: THE AMENDED PLAT OF ANGEL ISLAND WAS AMBIGUOUS REGARDING THE ACTUAL BOUNDARY OF THE WATER FRONT PROPERTIES, PARTICULARLY, THOSE ADJACENT TO THE "WATERWAY" "PARCEL A COMMON". AND "PARCEL B COMMON". TO RESOLVE THIS AMBIGUITY, THE ANGEL ISLAND COMMUNITY ASSOCIATION ISSUED A GRANT DEED, FILED IN BOOK 337 RECORDS, PAGE 120, LINCOLN COUNTY, MONTANA, RECORDS, CONVEYING THE LAND LYING BETWEEN THE UPLAND OWNERS AND THE LOW WATER MARK TO THE UPLAND OWNERS. THIS RETRACEMENT DELINIATES THE LOW WATER MARK BOUNDARIES FOR THE LOTS SHOWN HEREON.
