



PURPOSE OF SURVEY

The purpose of this survey is the boundary retracement of existing parcels and that no additional parcels are hereby created, and therefore this survey is exempt from review as a subdivision under both Montana Subdivision and Platting Act and the Montana Sanitation in Subdivision Act Section 76-3-404, MCA.

METHOD OF SURVEY

A Trimble R8 GNSS GPS system was used with RTK radial procedures to tie the previously set controlling corners by Byron Sanderson, August 2011.

BASIS OF BEARING

The basis of bearing for this survey is S 89°47'44" W derived from Survey Grade GPS system calibrated to local control between the C-N 1/16 Corner, Section 6 and the NW 1/16 corner, Section 6, both being a 3/4 inch diameter aluminum rod with 3 1/4 inch diameter, aluminum cap marked USFS, "9008LS"
