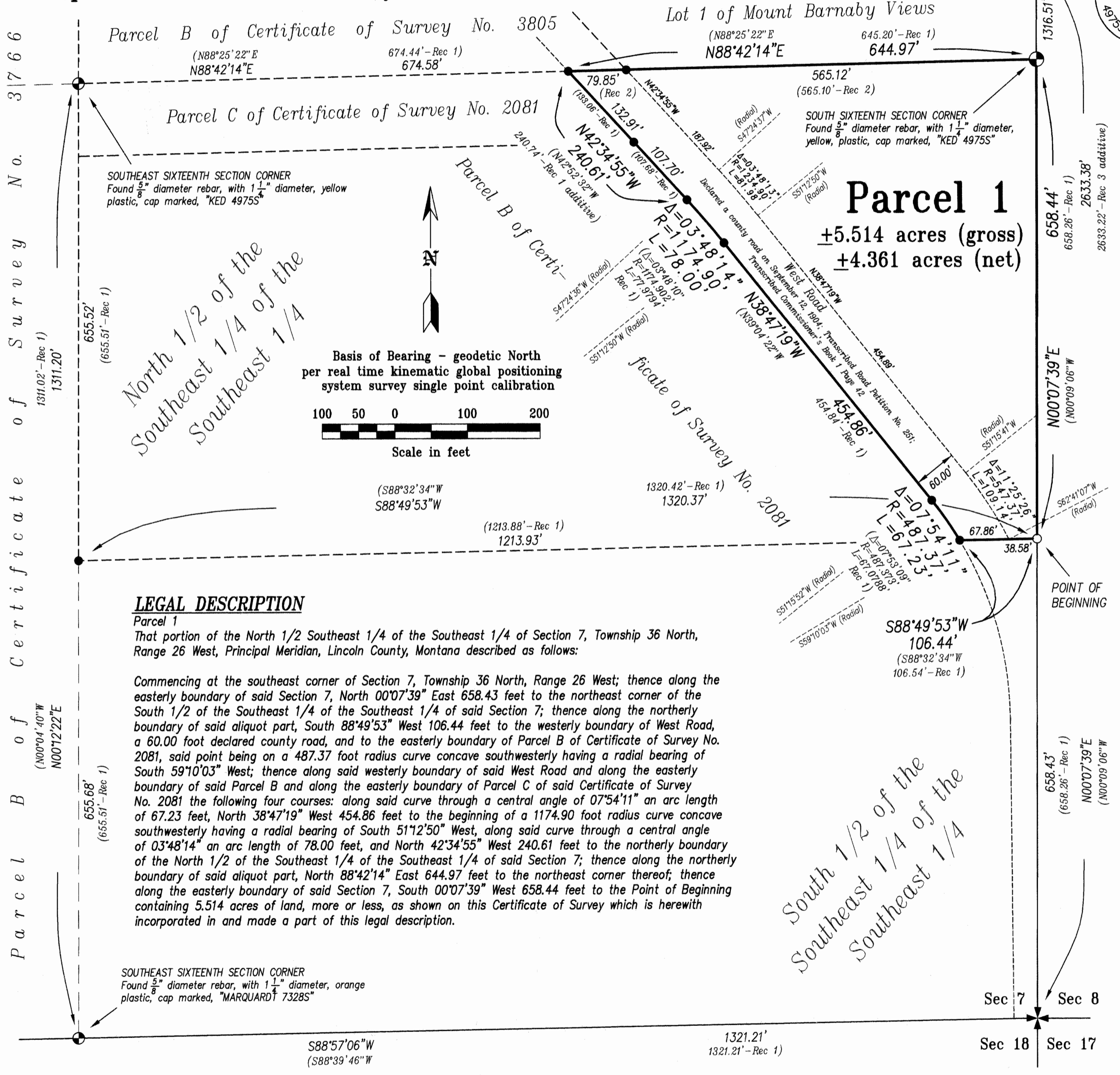
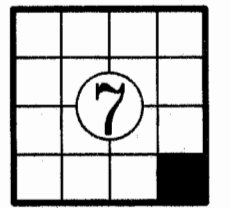

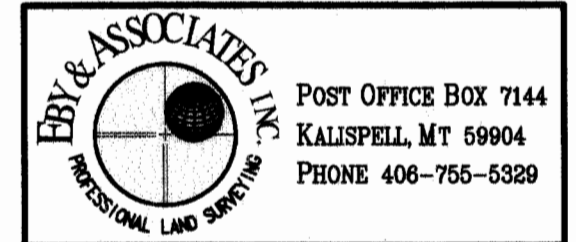

Found 3/4" diameter steel rod.
- ⚡ Quarter section corner.
Found 2 1/2" diameter aluminum pipe, with 3 1/4" diameter, aluminum cap marked as shown.
- ⊕ Sixteenth section corner.
Found monument as noted.
- Found 5/8" diameter rebar, with 1 1/4" diameter, yellow plastic, cap marked, "KED 4975S"
- Set 5/8" diameter rebar, 24" long, with 2" diameter aluminum cap marked, "EBY & ASSOCIATES" and "J.L.EBY 8694ES".

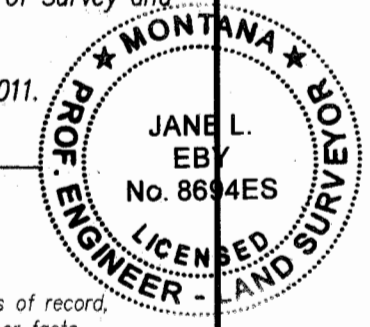
