TRACT 1

That portion of the Northeast one-quarter of the Northwest one-quarter (NE1/4NW1/4) of Section Twenty-one (21), Township Thirty-six North (T36N), Range Twenty-seven West (R27W), Principal Meridian, Montana, Lincoln County, Montana, more particularly described as follows:

Beginning at the northwest one-sixteenth (NW1/16) corner of said Section Twenty-one (21); thence North00°49'18"East 560.00 feet along the westerly boundary of the Northeast one-quarter of the Northwest one-quarter (NE1/4NW1/4) of said Section Twenty-one (21); thence South89°17'17"East 312.00 feet; thence South00°49'18"West 560.00 feet to the southerly boundary of said Northeast one-quarter of the Northwest one-quarter (NE1/4NW1/4) of Section Twenty-one (21); thence North89°17'17"West 312.00 feet along said southerly boundary to the point of beginning and containing 4.011 acres of land, gross measure, more or less. All as shown hereon.

Together with a thirty-foot (30') wide ingress and egress easement across Tract Two (2) of this survey, as shown hereon.



Commencing at the West one-sixteenth (W1/16) corner of said Section Twenty-one (21); thence South89°26'20"East 226.21 feet along the northerly boundary of said Section Twenty-one (21) to the center line of an existing roadway and the TRUE POINT OF BEGINNING of said strip of land, the center line of which is described as follows; thence South04°58'00"East 63.71 feet; thence South30°02'42"East 349.42 feet; thence South38°52'07"East 190.33 feet to the beginning of a non-tangent curve concave to the west having a radius of 55.95 feet and to which point a radial line bears North33°01'38"East; thence southeasterly, southerly and southwesterly 141.24 feet along said curve through a central angle of 144°37'41"; thence on a non-tangent line South77°21'18"West 138.60 feet; thence North69°22'10"West 75.95 feet; thence North84°55'39"West 43.08 feet to the beginning of a non-tangent curve concave to the southeast having a radius of 36.86 feet and to which point a radial line bears North11°08'26"West; thence southwesterly, southerly and southeasterly 96.91 feet along said curve through a central angle of 150°37'45"; thence on a non-tangent line South64°40'59"East 55.89 feet to the beginning of a non-tangent curve concave to the west having a radius of 46.18 feet and to which point a radial line bears North16°56'38"East; thence southeasterly, southerly and southwesterly 111.56 feet along said curve through a central angle of 138°23'55" to the easterly boundary of Tract One (1) of this survey and containing 0.872 acres of land, gross measure, more or less. 
