DESCRIPTION OF PARCEL A

A tract of land near Troy, in Lincoln County Montana, lying in the NW 1/4 NW 1/4 of Section 13, Twp. 31 N., R. 34 W., P.M.M., containing 12.934 acres more or less and more particularly described as follows:

Beginning at a 5/8 inch dia. rebar capped J.H.N. 4661-S which marks the northwest corner of that parcel as described on C.O.S. 663 and located on the east right-of-way line of Manier Road a private roadway; thence along said east right-of-way line, S40°48'15"E 88.93 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence on the arc of a curve to the right, a distance of 63.62 feet, turning through a delta angle of 12°09'04", and having a radius of 300.00 feet, to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S28°39'11"E 27.06 feet to a 5/8 inch dia. rebar capped J.H.N. 4661-S; thence on the arc of a curve to the left, a distance of 108.51 feet, turning through a delta angle of 09°52'08", and having a radius of 630.00 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S38°31'19"E 83.01 feet to a 5/8 inch dia. rebar capped J.H.N. 4661-S; thence on the arc of a curve to the left, a distance of 94.68 feet, turning through a delta angle of 03°34'48", and having a radius of 1515.27 feet, to a 5/8 inch dia. rebar capped K.E.D. 49 75-S having a radial bearing of N47°53'53"E and located on the east boundary of the NW 1/4 NW 1/4 of Section 13, Twp. 31 N., R. 34 W., P.M.M.; thence along said east boundary of the NW 1/4 NW 1/4, S00°02'55"W 17.89 feet to a computed point located on the north right-of-way of Callahan Creek Road per Plat No. 671 and having a radial bearing of S48°05'50"E; thence along said north right-of-way line, on the arc of a curve to the left, a distance of 50.11, turning through a delta angle of 05°13'11", and having a radius of 550.00, to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence leaving said north right-of-way, N73°23'55"W 490.04 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N88°33'29"W 426.82 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N06°39'03"W 62.56 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S located on the east right-of-way of said Manier Road; thence continuing, N06°39'03"W 61.86 feet to a computed point located on the approximate centerline of said Manier Road; thence along said centerline, N07°31'59"E 62.85 feet to a computed point; thence on the arc of a curve to the left, a distance of 112.97 feet, turning through a delta angle of 08°37'50", and having a radius of 750.00 feet, to a computed point; thence, N01°05'51"W 85.33 feet to a computed point; thence on the arc of a curve to the right, a distance of 238.21 feet, turning through a delta angle of 27°17'47", and having a radius of 500.00 feet, to a computed point; thence continuing on the arc of a curve to the right, a distance of 32.37 feet, turning through a delta angle of 12°21'54", and having a radius of 150.00 feet to a computed point located on the north section line of said Section 13, Twp. 31 N., R. 34 W., P.M.M. having a radial bearing of S51°26'09"E; thence leaving said centerline, along said north section line, S89°56'00"E 42.02 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S located on the east right-of-way line of said Manier Road; thence continuing, S89°56'00"E 763.95 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, S00°05'15"W a total distance of 364.09 feet to a bare 5/8 inch dia. rebar; thence, N89°58'41"W 224.66 feet to the point of beginning.

The aforedescribed Parcel A contains 12.93 acres more or less and is subject to and together with all appurtenant easements of record.

DESCRIPTION OF PARCEL B

A tract of land near Troy, in Lincoln County Montana, lying in the NW 1/4 NW 1/4 of Section 13, Twp. 31 N., R. 34 W., P.M.M., containing 23.00 acres more or less and more particularly described as follows:

Beginning at a 3 1/4 inch dia. brass BLM monument which marks the section corner common to Sections 11, 12, 13, & 14, of Twp. 31 N., R. 34 W., P.M.M.; thence along the west section line of said Section 13, S00°04'09"W 1337.28 feet to a 3 1/4 inch dia. alum. U.S.F.S. monument which marks the N 1/16th of said Section 13; thence, S89°59'11"E 910.46 feet along the south line of the NW 1/4 NW 1/4 to a 5/8 inch dia. rebar capped K.E.D. 4975-S located on the west right-of-way of Callahan Creek Road per Plat No. 671 and having a radial bearing of S68°03'01"E; thence along said west right-of-way, on the arc of a curve to the right, a distance of 167.15 feet, turning through a delta angle of 14°44'00", and having a radius of 650.00 feet, to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N36°40'59"E 498.01 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence leaving said right-of-way N73°23'55"W 490.04 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N88°33'29"W 426.82 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S; thence, N06°39'03"W 62.56 feet to a 5/8 inch dia. rebar capped K.E.D. 4975-S located on the east right-of-way of Manier Road a private roadway; thence continuing, N06°39'03"W 61.86 feet to a computed point located on the approximate centerline of said Mainer Road; thence along said centerline, N07°31'59"E 62.85 feet to a computed point; thence on the arc of a curve to the left, a distance of 112.97 feet, turning through a delta angle of 08°37'50", and having a radius of 750.00 feet, to a computed point; thence, N01°05'51"W 85.33 feet to a computed point; thence on the arc of a curve to the right, a distance of 238.21 feet, turning through a delta angle of 27°17'47", and having a radius of 500.00 feet, to a computed point; thence continuing on the arc of a curve to the right, a distance of 32.37 feet, turning through a delta angle of 12°21'54", and having a radius of 150.00 feet to a computed point located on the north section line of said Section 13, Twp. 31 N., R. 34 W., P.M.M. and having a radial bearing of S51°26'09"E; thence leaving said centerline along said north section line, N89°56'00"W 458.78 feet to the point of beginning.

The aforedescribed Parcel B contains 23.00 acres more or less and is subject to and together with all appurtenant easements of record.


