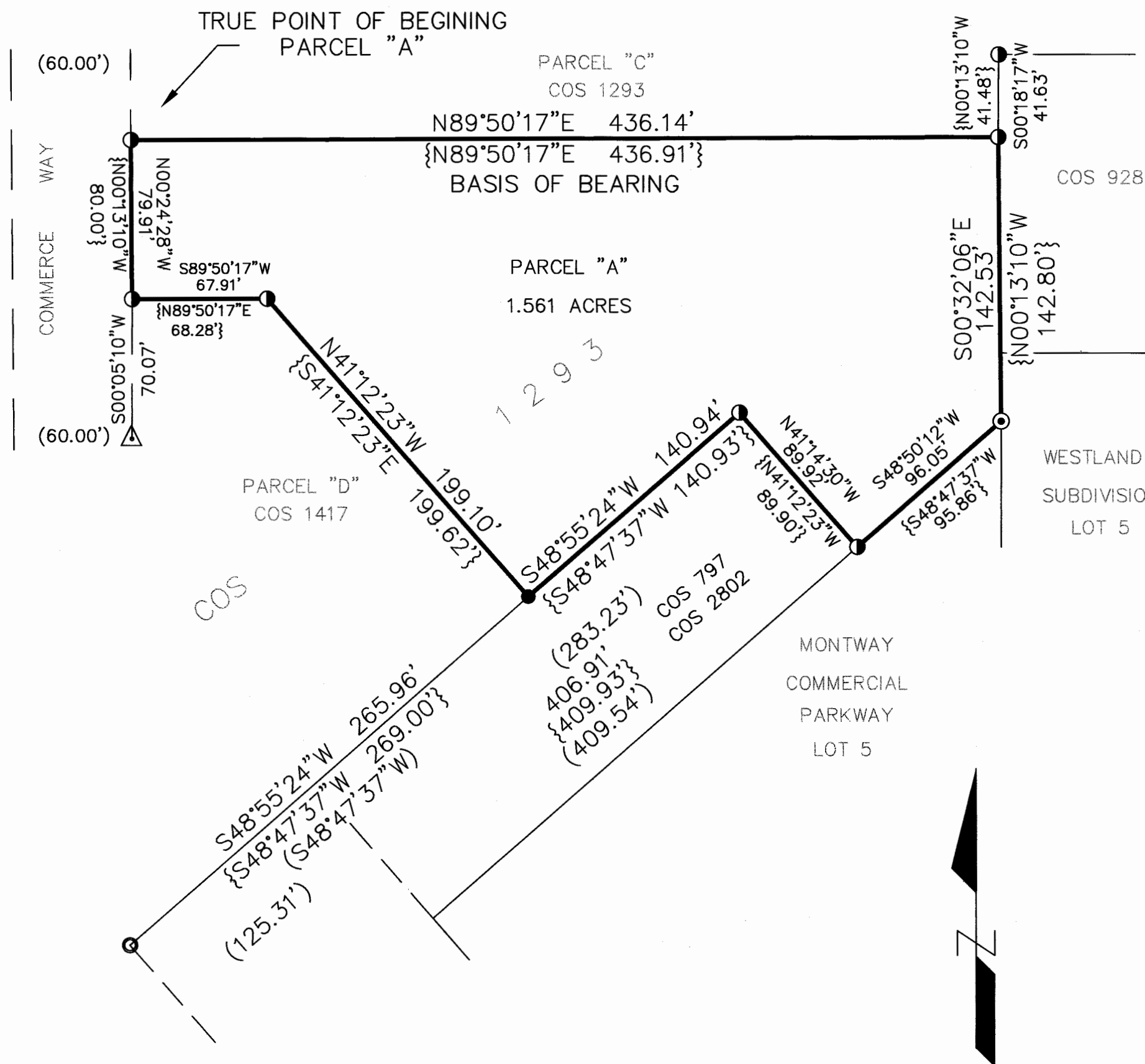

DESCRIPTION PARCEL "A"

A irregular tract of land lying southeast of Libby, Lincoln County, Montana, and in the SE1/4NE1/4, section 4, T. 30 N., R. 31 W., Principal Meridian, Montana, and more particularly described as follows:

Commencing at a 5/8 inch diameter rebar with a plastic cap marked MDL 4232S marking the Northwestern corner of "Parcel B" as shown on COS No. 1293 and a point on the Easterly right of way limit of Commerce Way, a 60 foot wide Dedicated Road and True Point of Beginning; Thence N89°50'17"E, 436.14 feet to a 5/8 inch diameter rebar capped MDL 4232S; Thence S00°32'06"E, 142.53 feet to a 1/2 inch I.D. diameter iron pipe uncapped; Thence S48°50'12"W, 96.05 feet to a 5/8 inch diameter rebar uncapped; Thence N41°14'30"W, 89.92 feet to a 5/8 inch diameter rebar capped MDL 4232S; Thence S48°55'24"W, 140.94 feet to a 5/8 inch diameter rebar capped Boyer 9750LS; Thence N41°12'23"W, 199.10 feet to a 5/8 inch diameter rebar capped MDL 4232S; Thence S89°50'17"E, 67.91 feet to a 5/8 inch diameter rebar uncapped and a point on the Easterly right of way limit of said "Commerce Way" Road; Thence N00°24'28"W, 79.91 feet along said Easterly right of way limit of "Commerce Way" Road, to a 5/8 inch diameter rebar capped MDL 4232S and the True Point of Beginning. Containing 1.561 acres more or less and is subject to and together with all appurtenant easements of record.



PURPOSE OF SURVEY

The purpose of this survey is to retrace the exterior boundary of an existing tract of record (Bk. 231 Pg. 871), Lincoln County Records and that no further division of land is hereby created; therefore, this survey is exempt from review, pursuant to Section 76-3-404 M.C.A.

METHOD OF SURVEY

A Total Station with electronic data collector was used with closed traverse and radial procedures to tie previously set controlling corners and road alignments.

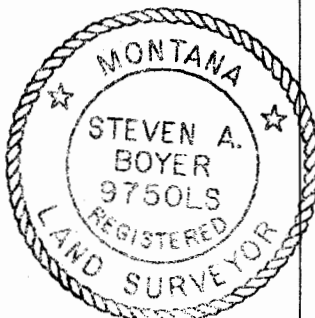
BASIS OF BEARING

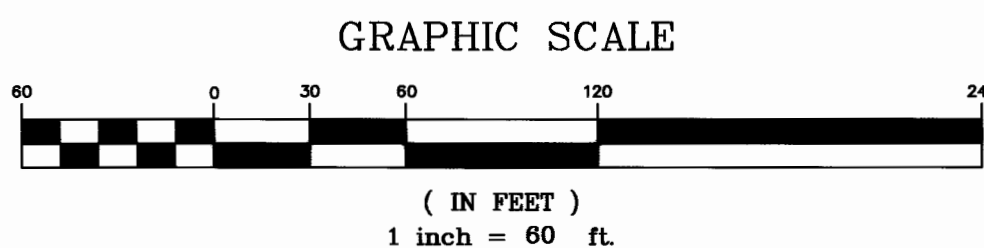
