

PURPOSE OF SURVEY

The purpose is the resurvey of record parcels of land, "A" & "B" in Government Lot 6, and reestablish corners and mark property boundaries. Therefore no division of land is hereby created and is exempt from review as a subdivision pursuant to Section 76-3-404 MCA.

BASIS OF BEARING

The basis of bearing for this survey is N89'51'53"W derived from Survey Grade GPS system calibrated to local control between the Quarter Corner, Sections 2 and 11, a 1 1/2 inch diameter iron pipe with 3 1/4 inch diameter BLM brass cap and the W 1/16th corner, between said Sections, a 5/8 inch diameter aluminum rod with 3 1/4 inch diameter USFS aluminum cap marked 2734S.

<u>METHOD OF SURVEY</u> A Nikon total station with data collector and a Trimble R8 GNSS GPS system was used with RTK radial procedures to tie the previously set controlling corners and road alignme by Levi Powell, April 2015. ments
