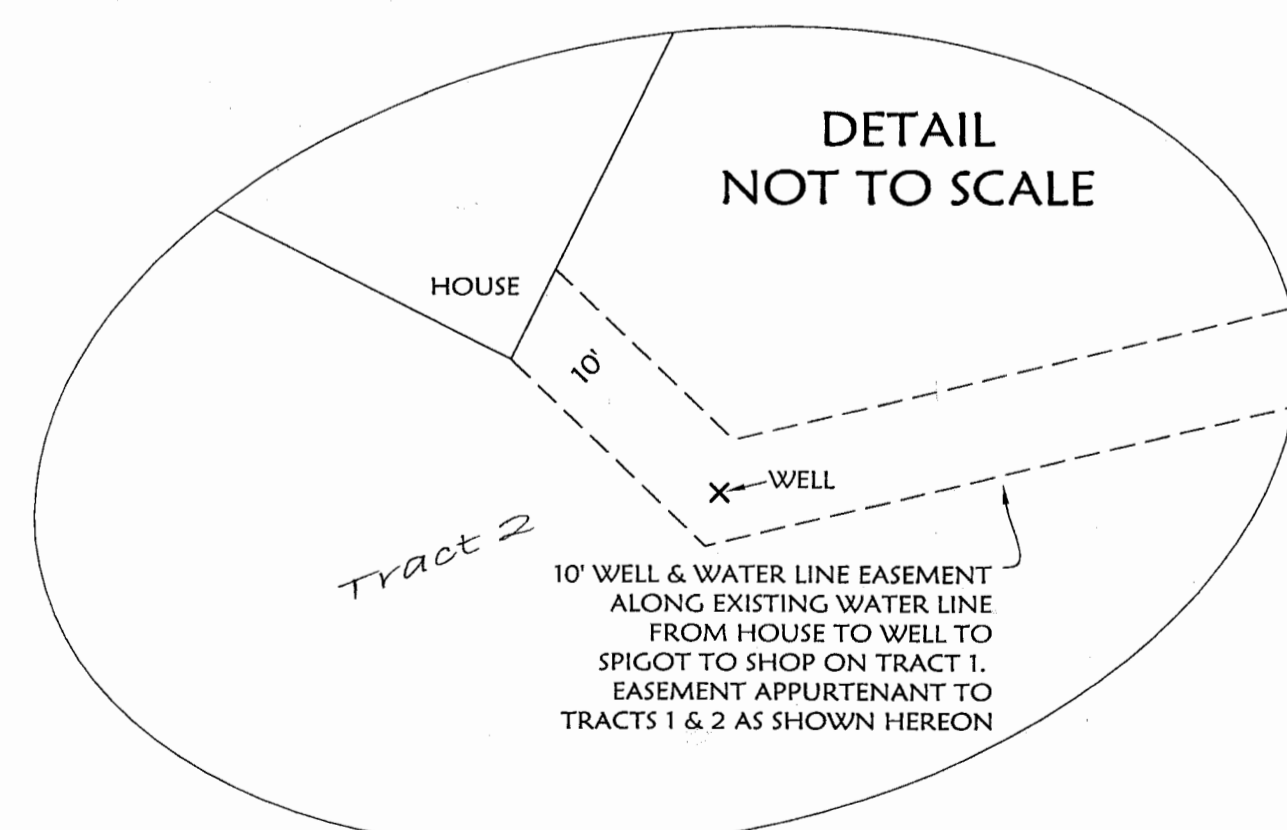
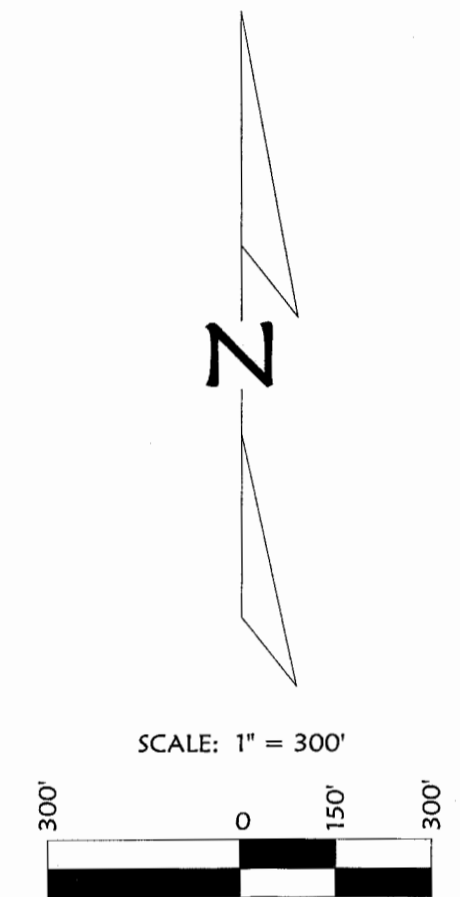
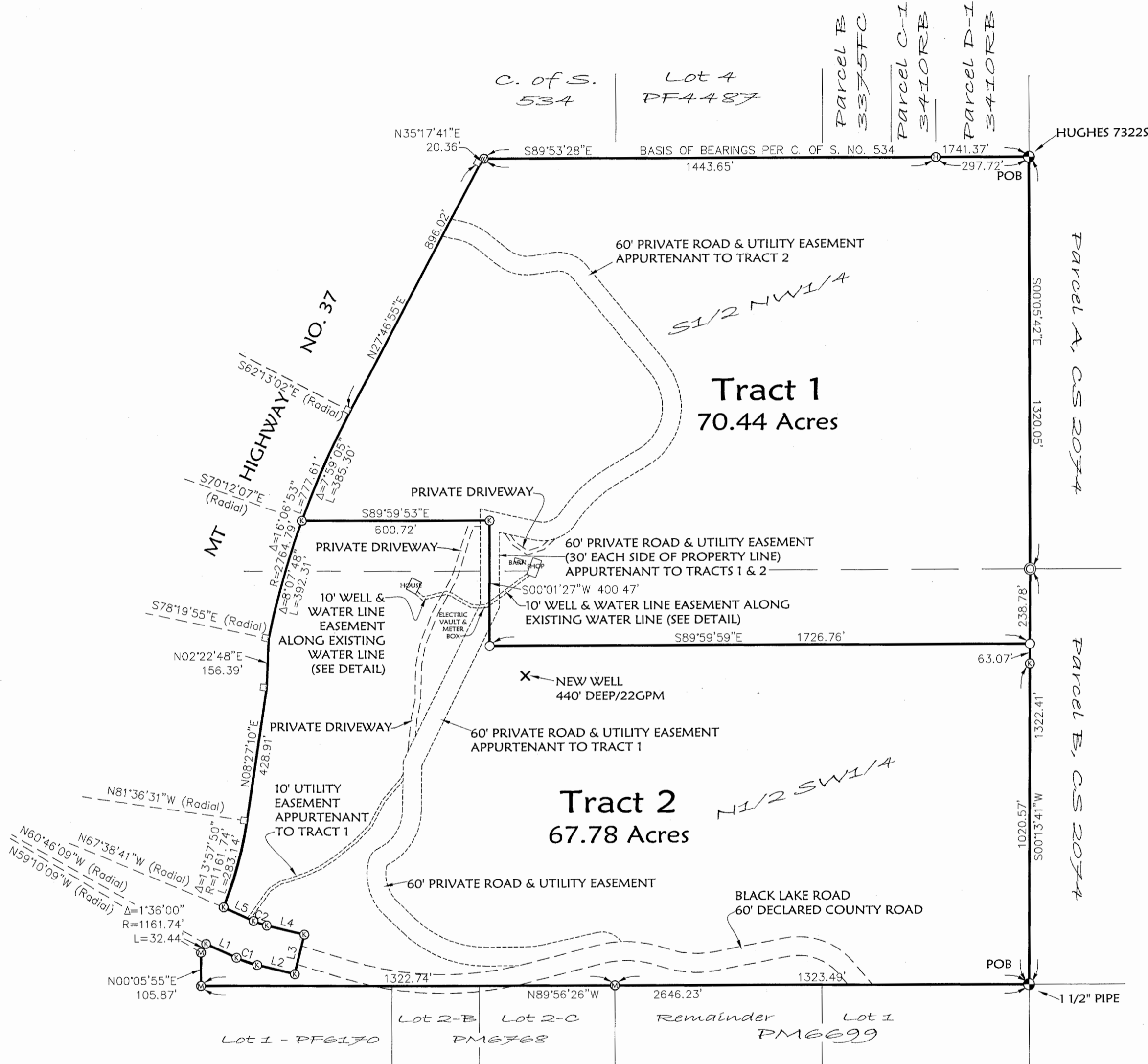

Beginning at the Northeast corner of the South 1/2 of the Northwest 1/4;  
Thence along the East line of the South 1/2 of the Northwest 1/4, South 00°05'42" East 1320.05 feet to the Northeast corner of the North 1/2 of the Southwest 1/4;  
Thence along the East line of the North 1/2 of the Southwest 1/4, South 00°13'41" West 238.78 feet;
