A Nikon total station with data collector and a Trimble R8 GNSS GPS system was used with RTK radial procedures to tie the previously set controlling corners and road alignments by Levi Powell, April, 2019.

BASIS OF BEARING

The basis of bearings for this survey is N00°14'28"W as determined with a Trimble R8-2 GNSS system calibrated to True North. Angular variation between COS 3695RB and this survey is -00°06'34" as determined between the NE and SE property corners of Tract 2, COS 3695RB.
