

Beginning at the Center one-quarter corner (C1/4) of said Section Six (6); thence South00°06'40"West 651.10 feet along the easterly boundary of the Southwest one-quarter (SW1/4) of said Section Six (6); thence South88°41'29"West 1330.86 feet to the westerly boundary of the Northeast one-quarter of the Southwest one-quarter (NE1/4 SW1/4) of said Section Six (6); thence North00°16'11"West 657.64 feet along said westerly boundary to the center-west one-sixteenth corner (C-W 1/16) of said Section Six (6); thence North88°58'33"East 1335.08 feet along the northerly boundary of said Southwest one-quarter (SW1/4) of Section Six: (6) to the point of beginning and containing 20.020 acres of land, gross measure, more or less.
