BASIS OF BEARINGS

Bearing Datum is Universal Transverse Mercator (UTM), Zone 11 NAD 83, Derived From GPS Static and RTK observations with Trimble R-8 Dual Frequency

A Combined State Plane and Sea Level Factor (CAF) of 1.00041895 has been directly applied to UTM, Zone 11, NAD 83 coordinate datum in order to represent actual ground distances. Geodetic North is an angular rotation of 1°09'34" to the right at the Southwest Corner of Section 9, T.31N., R.30W.

METHOD OF SURVEY

The control survey was by GPS static and RTK observations, performed using TRIMBLE R-8, DUAL FREQUENCY GPS RECEIVERS. Data processed using NGS OPUS Static positioning for base points and Trimble Business Center software. The survey was completed by conventional traverse and radial tie techniques using a total station.

PURPOSE OF SURVEY

To monument and mark the boundary of lands owned by Stimson Lumber Co. in Section 9, T.31N., R.30W., P.M.M., Lincoln County, Montana.


