

Department of Environmental Quality pursuant to ARM 17.36.605(2)(a):"a parcel that has no facilities for water supply, wastewater disposal, storm drainage, or solid waste disposal, if no facilities will be constructed on the parcel'

METHOD OF SURVEY

A Trimble R10-2 GNSS system and Trimble S6 Robotic Total Station were used to tie previously set controlling corners by Byron Sanderson, June, 2022.

The basis of bearing for this survey is NO0'22'33"W between the southeast Section Corner, Section 3, a 2 inch diameter brass cap set in concrete marked 534ES and the northeast Section Corner, Section 3, a 2 1/2 Inch diameter iron pipe with 3 1/4 inch diameter BLM brass cap as established with a Trimble R10-2 GNSS system calibrated to True North.

BOUNDARY ADJUSTMENT NOTE

The area that is being removed from one tract of record and joined with another tract of record is not a tract of record. Said area shall not be available as a reference legal description in any subsequent real property transfer after the initial transfer associated with this certificate of survey on which said area is described, unless said area is included with or excluded from adjoining tracts of record.
