THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, **MONTANA FINDS:** 

WHEREAS, the Montana Districting and Apportionment Committee has redrawn legislative districts for the State of Montana; and

WHEREAS, the Board of Commissioners have received a map and legal description of the same, a copy of each is attached hereto, and reflect that Lincoln County shall be within House Districts I and 2 and Senate District I; and

WHEREAS, the Board of Commissioners have reviewed the attached map and description of the same, and according to Section 13-3-102, Montana Code Annotated, the Board must adopt the said boundaries and then certify such boundaries to the Lincoln County Election Administrator.

### THE BOARD RESOLVES:

That Lincoln County shall be within House Districts I and 2 and Senate District I, in accordance with the attached map and legal description/metes & bounds.

### THE BOARD FURTHER RESOLVES:

- 1, If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
- 2. This resolution and its various sections, clauses and paragraphs are severable. If any part, sentence, clause, or phrase is adjudged to be unconstitutional or invalid, the remainder of




