WHEREAS, 13-3-102, MCA, states that when changes are required to make precinct boundaries confirm to legislative district boundaries following the adoption of a districting and apportionment plan under Article V, section 14, of the 1972 Montana constitution or other district boundaries changed by the districting and apportionment plan, the changing of precinct boundaries must be accomplished within 45 days of the filing of the final plan; and

WHEREAS, the final legislative redistricting plan was filed on February 22, 2023; and
WHEREAS, the officials responsible for preparing a districting and apportionment plan have considered the problems of conforming present precinct boundaries to the new districts.

## THE BOARD RESOLVES:

That the precinct boundaries are hereby defined and identified and numbered attached hereto as Exhibit "A" by this reference made a part of.

## THE BOARD FURTHER RESOLVES:

1. If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
2. This resolution and its various sections, clauses and paragraphs are severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or invalid, the remainder of the resolution will not be affected.
3. This resolution will be effective immediately upon adoption, in accordance with § 7-5-123, MCA.
4. This Board directs that this resolution be entered into the minutes and signed by the Chair of the Board in accordance with § 7-5-121, MCA.
