A RESOLUTION OF THE LINCOLN COUNTY RURAL FIRE DISTRICT #1 PROVIDING FOR THE ADOPTION OF THE 2021 INTERNATIONAL FIRE CODE AND CERTAIN AMENDMENTS

THE BOARD OF COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

WHEREAS, it is requested for the adoption by reference of the 2021 edition of the International Fire Code and replacing the 2012 International Fire Code to be enforced by the Lincoln County Rural Fire District #1 within its jurisdictional boundaries.

WHEREAS, The International Fire Code, 2021 edition, as published by the International Code Council, regulates and governs the safeguarding of life and property from fire and explosion hazards arising from the storage, handling and use of hazardous substances, materials and devices, and from conditions hazardous to life or property in the occupancy of buildings and premises as herein provided and provides for the issuance of permits and collections of fees.

THE BOARD RESOLVES:

The Board of Lincoln County Commissioners hereby resolves to approve the adoption by reference of the 2021 edition of the International Fire Code as published by the International Code Council. All of the regulations, provisions, penalties, conditions and terms of said fire code on file in the office of the fire district are hereby referred to, adopted, and made part hereof, as if fully set out in this resolution, with the additions, insertions, deletions and amendments, if any, prescribed in this resolution and ARM 23.12.601.

THEREFORE, The following sections of the fire code are revised as set out below:

101.1 Insert: (Lincoln County Rural Fire District #1, Libby, MT) so that such section shall read:

Section 101.1 Title. These regulations shall be known as the Fire Code of the Lincoln County Rural Fire District #1 hereinafter referred to as "this code".

112.4 Insert: (Misdemeanor, \$500.00, 6 months) so that shall read:

Section 112.4 Violation Penalties. Persons who shall violate a provision of this code or shall fail to comply with any of the requirements thereof or who shall erect, install, alter, repair or do work in violation of the approved construction documents or directive of the fire code official, or of a permit or certificate used under provisions of this code, shall be guilty of a misdemeanor, punishable by a fine of not more than \$500.00 or by imprisonment not exceeding 6 months, or both such fine and imprisonment. Each day that a violation continues after due notice has been served shall be deemed a separate offense.

THE BOARD FURTHER RESOLVES:

1. If a provision of this resolution conflicts with a provision of a previously adopted resolution, this resolution will prevail.
2. This resolution will be effective immediately upon adoption, in accordance with § 7-5-123, MCA.
3. This resolution and its various sections, clauses and paragraphs are severable. If any part, sentence, clause or phrase is adjudged to be unconstitutional or invalid, the remainder of the resolution will not be affected.
4. This Board directs that this resolution be entered into the minutes and signed by the Chair.
