The board shall approve the annexation unless a protest petition signed by at least 40% of the owners of real property in the area proposed for annexation and owners of property representing 40% or more of the taxable value of the property in the area proposed for annexation is presented at the hearing, in which case the annexation must be disapproved".

Pursuant to 7-33-2103(b), M.C.A. states, "Signatures may not be withdrawn fewer than 20 days before the date set for adoption of the petition".

NOTICE IS HEREBY GIVEN that a public hearing will be held by the Lincoln County Board of Commissioners on the 4th day of January 2023, at 10:30 A.M. in the Lincoln County Courthouse, located at 512 California Ave, Libby Montana to hear protests and public comments relating to the proposed annexation.




