- Lakeshore Permit Review (After the Fact) Lincoln County (Bull Lake)
 - J. Haag introduces the project and reads the staff report. After the fact permit was necessary as contractor initially thought project was exempt. Rising lake water disturbed the temporary road access which caused a sloughing of material into the lake, and created unsafe conditions of the temporary road. Project seeks to remove sloughed materials, remove temp road, and restabilize the main road. Planning department recommends approval with 11 conditions.
 - Board discusses the need to ensure machinery is clean of grease before commencement of work in lake.
 - o M. Fraser discusses project details including the existing creosote pilings.
 - S. Mattheis motion to approve with conditions as written. Seconded by E. Anderson.
