## Resolution 2023-27

### AMENDED

#### RESOLUTION TO SET ELECTED OFFICIAL BASE SALARIES

#### THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY, MONTANA FINDS:

WHEREAS, on July 12, 2023, the Lincoln County Commissioners adopted Resolution 2023-18, to set elected official base salaries; and

WHEREAS, it has been realized that Resolution 2023-18 did not correctly reflect the recently published State Share of the County Attorney distribution for the fiscal years 2024 and 2025.

#### THE BOARD RESOLVES:

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners for Lincoln County Montana, that Resolution 2023-18 shall be amended as follows:

1. The base salary for the County Attorney shall remain set at \$62,232.94, which is the county portion.
2. In addition to the county portion, the State Share of the County Attorney distribution for fiscal years 2024 and 2025 shall be \$63,271, effective as of July 1, 2023.






