RESOLUTION 2023-28

A RESOLUTION OF INTENT TO AMEND TROY TV DISTRICT FEE SCHEDULE

THE BOARD OF COUNTY COMMISSIONERS FOR LINCOLN COUNTY,
MONTANA FINDS:

1. The Board of County Commissioners created the Troy TV District under MCA 7-11-1004.
2. On August 24, 2023, the Board of County Commissioners received a request from the Board of Directors of the Troy TV District to amend the fee schedule as follows:

PRESENT FEE	PROPOSED FEE
\$15 / year	\$25 / year

Whereas, the costs and expenses of the District are more than revenues collected from the current annual assessment; and

Whereas, the new Troy TV District assessment fee will be effective November 30, 2023, and will remain in effect until such time as it is changed by the Board of County Commissioners; and

Whereas, any comments or protests to the proposed assessment fee increase shall be addressed in writing to the Lincoln County Clerk and Recorder's Office, 512 California Ave. Libby, MT 59923 prior to Monday October 2, 2023, at 8:00 am local time.

NOW, THEREFORE BE IT RESOLED

1. The board of County Commissioners intends to amend the fee schedule within the Troy TV District pursuant to MCA 7-11-1024 as set forth above.
2. The Board of County Commissioners shall proceed to hear and pass upon all protests so made at a public hearing on Wednesday October 4, 2023, at 11:00 am in Room 108 of the Lincoln County Courthouse, 512 California Ave. Libby, MT 59923.
3. A Public Notice will be issued pursuant to Section 7-1-2121 MCA.
