

 - A fallen fir, 13 ins. diam., bears S40°E, 43.9 ft. dist., visible scribing. (Original) A douglas fir, 16 ins. diam., bears S16°W, 15.5 ft. dist., visible scribing.

 - A douglas fir, 13 ins. diam., bears N72 W. 25.2 ft. dist., visible scribing.
