

A Pine, 5 inches in diameter, bears S 1710E 58 links distance, marked T25N., R. 29W S 11 B.T. A Pine 5 inches in diameter, bears S 26½°W., 66 links distance, marked T25N.,R 29W S 10 B.T. A Fir 18 inches in diameter, bears N21½°W 47 links distance, marked T25N., R. 29W S 3 B.T.
- 2. Found: BLM brass capped monument (marked as shown below) from which a 36" Fir bears N 3320E 120.1 feet 29W S 2 visible on partially overgrown blaze. A 27" Fir bears N 21½°W 31.0 feet 29W S 3 B.T. visible on partially overgrown blaze. A 12" Fir bears S50°E 30.4 feet scribed T25N.,R.29W S 11 B.T. An 8" Fir bears S46°W 27.7 feet scribed T25N.,R.29W S 10 B.T. A location poster bears South 7.9 feet. All B.T.s posted.
