4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories.
5. Certification must be signed and sealed by Land Surveyor registered in the State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

CERTIFIED CORNER RECORDATION

RECORD:

MS No. 6192 Pan Handle

1500 N.W. location corner. Set a post, 4 1/2 ins. square, 5 ft. long, 2 ft. deep, marked 3-6194, for Cor. No. 3, and raised a mound of earth and stone around post.

FOUND:

Found no remaining evidence of post or the mound of stone.

TO PERPETUATE:

At record position, set a 5/8" x 24" rebar flush with the surface, with a USFS 3-1/4" aluminum cap, marked as shown below.

From which new trees:

A fir, 5" in diam., bears S.16°E., 16.9', blazed and scribed "3 MS 6192 BT".

A fir, 7" in diam., bears N.81°W., 11.4', blazed and scribed "3 MS 6192 X BT".

Place a "Land Survey Monument" (54-9), and a "Bearing Tree" (54-3) sign on the bearing trees. Painted all blazes red, and a 6" red band above the "Bearing Tree" signs. Placed 6' steel posts on property line, 3' +/- from the corner with "Land Survey Marker" (54-9), and "Property Boundary" (54-2) decals.
