

**INSTRUCTIONS**

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Land Surveyor registered in the State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

**ORIGINAL AND/OR SUBSEQUENT RECORD**

**ORIGINAL RECORD:** Set a Limestone 24"x10"x4", 18" in the ground, marked CC on S with 3 grooves on E and W faces  
 From Which:  
 A Fir 6" in diam. bears S56°E, 19 lks. dist. marked T26N R27W S3 B.T.  
 A Tamarack, 30" in diam bears S66°30'W 15 lks. dist. marked T26N R27W S4 B.T.

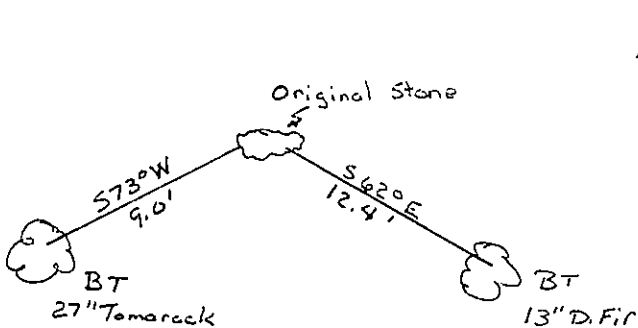
**EVIDENCE FOUND**

Found Set stone, 5"x9" above ground. From Which a 27" Tamarack bears S73°W 9.0'. A 13" D. Fir bears S62°E 12.4'

**PERPETUATION**

Left stone in place and set steel Fence Post with CIC Property Sign attached, 1' South of monument. Placed a MARLS Land Monument Sign on original BT's and painted Red Band around Trees.

Note: Declination used - 19° E  
 Measurements taken to center of tree
