26 North R. 29 West P.M.M. Lincoln Corner S1/4 Sec. 34

Original G.L.O. Record: Charles H. Albee and William K. Trippet 1903

Set a limestone, 16x14x10 inches, 11 inches in the ground, for 1/4 section corner, marked 1/4 on North face; from which:

A 14" fir, bears \$75°30'W, 110 links (72.6 feet) distant, marked "1/4 \$ 3 BT".

A 30" pine, bears N36°10'W, 57 links (37.62 feet) distant, marked "1/4 S 34 BT".

Remonument: 1978

The 1/2 corner of Sections 3 and 34 on north boundary of the township being monumented with a limestone, 16 x 14x 10 inches, firmly set 11 inches in the ground, marked 1/4 on the North face and witnessed by the remains of the original bearing trees:

A 24" fir stump, bears S75 1/2°W, 100 links (66 feet) distant, with the remains of a fir lying alongside.

A 42" pine snag, bears N36°10'W, 68 links (44.88 feet) distant, marked "1/4 S34 BT". (Record: 57 links.)

At the corner point set an iron post, 30" long, 2 1/2" diameter, 22" in the ground, with brass cap marked as shown below From which new bearing trees:

An 8" fir, bears S64°W, 22 links (14.52 feet) distant, marked "1/4 S3 BT".

An 8" fir, bears N41°W, 21 links (13.86 feet) distant, marked "1/4 S34 BT".

bury the original stone alongside the iron post.

Found 3 1/2" brass cap on 2 1/2" pipe, 7" above ground. From which:

A 42" dead standing Ponderosa pine, bears N36 1/4°W, 45.86 feet distant, scribed "1/4 S34 BT". (Record)

A 15" dead standing Douglas Fir, bears N44 1/20W, 13.88 feet distant, marked with a BT tag and scribed "1/4 S34 BT".


A 15" Douglas Fir, healed scribe wound, bears S62% W, 14.67 feet distant.
