2009 Perpetuation: At a position established by the survey and section breakdown of Section 34, we set a 5/8"x30" rebar, 26" in the ground affixed with a 3 1/4" U.S.F.S. alum. cap marked as shown below, from which we establish the following reference monuments:


- A 12" Tamarack, bears N70°W, 4.2 ft., scribed NWNW 1/64 S34 BT
- A 13" Tamarack, bears N51°E, 25.2 ft., with an "X" cut at breast height

We build a mound of stone around the monument.

We set galvanized steel posts with U.S.F.S. decals P54-1 and P71-10, 0.9 ft., east and 0.9 ft., south of the monument.

We paint red bands on the bearing trees and attach USFS signs 54-3 & 54-9.
