2009 Perpetuation: At a position established by the survey and section breakdown of Section 34, we set a 5/8"x30" rebar, 26" in the ground w/ 3-1/4" U.S.F.S. alum cap, marked as shown below, from which we establish the following reference monuments:

A 10" Douglas fir, bears N19°E, 18.9 ft., scribed S-N-N 1/256 S34 BT

A 10" Douglas fir, bears N79°E, 19.0 ft., with an "X" cut at breast height

We build a mound of stone around the monument.

We set galvanized steel posts with U.S.F.S. decals P54-1 and P71-10, 0.7 ft., east and 1.8 ft., north of the monument.

We paint red bands on the bearing trees and attach USFS signs 54-3 &amp; 54-9.

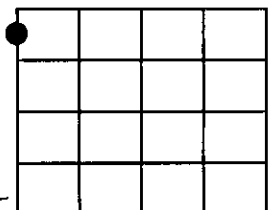
