2009 Perpetuation: At a position established by the survey and section breakdown of Section 34, we set a 5/8"x30" rebar, 20" in the ground affixed with a 3 1/4" U.S.F.S. alum cap, marked as shown below, from which we establish the following reference monuments:

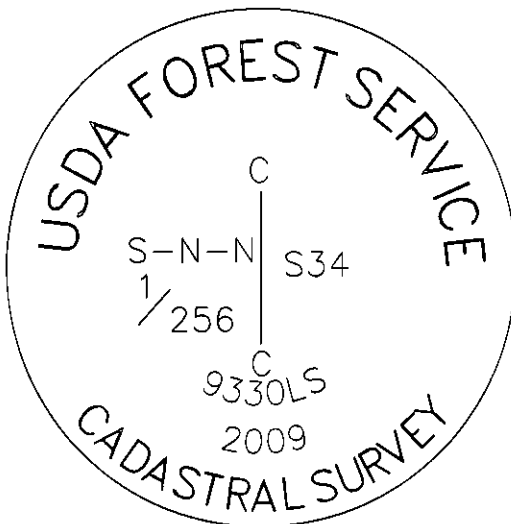
A 12" Douglas fir, bears S49°E, 21.4 ft., scribed CSNN 1/256 S34 BT

A 17" Douglas fir, bears S78°W, 1.3 ft., with an "X" cut at breast height

We build a mound of stone around the monument.

We set galvanized steel posts with U.S.F.S. decals P54-1 and P71-10, 0.5 ft., north and 0.7 ft., west of the monument.

We paint red bands on the bearing trees and attach USFS signs 54-3 &amp; 54-9.

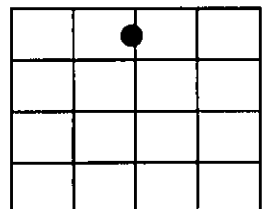
