A 14" Douglas fir, bears S33°E, 22.3 ft., scribed "X" at breast height




A 13" Douglas fir, bears N50°E, 5.2 ft., scribed CENW 1/164 S34 BT

We build a mound of stone around the monument.

We set galvanized steel posts with USFS decals P54-1 &amp; P71-10, south and east of the monument.

We paint red bands on the bearing trees and attach USFS signs 54-3 &amp; 54-9.



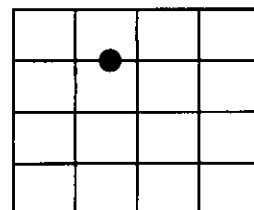
