

# CERTIFIED CORNER RECORDATION

Corner 2 MS 7366A Sec. 12 T. 26 N R. 31 W P.M., MT Lincoln County  
3 MS 7367A

I. 1904 G.L.O. survey by Abram L. Jaqueth: For corner 2 of MS-7366A, Giant Lode, set a quartzite stone, 30 x 24 x 8 ins., 25 ins. deep, chiseled 2-7366A, from which:

A hemlock, 24 ins. diam., bears S21°35'W, 65.5 ft. dist., scribed "B.T. 2-7366A".  
A balsam fir, 24 ins. diam., bears S41°10'W, 71.9 ft. dist., scribed "B.T. 2-7366A".

Corner 3 of MS-7367A is coincident with corner 2 of MS-7366A. While surveying MS-7367A, Jaqueth found a quartzite stone, 24 x 8 x 5 ins. above ground, mkd. 2-7366A. He marked it 3-7367A on NE face.

II. Found a stone, firmly set, 18 x 7 ins., 8 ins. above ground, mkd. "2-7366A" on the NW face and "3-7367A" on the NE face, from which:

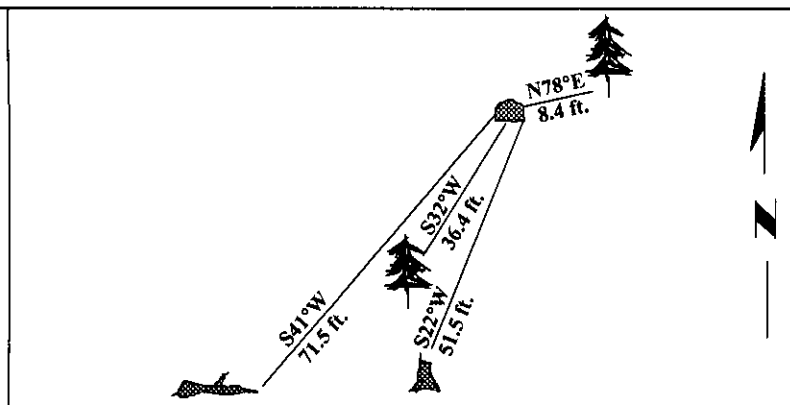
A stump, 5 ft. tall, bears S22°W, 51.5 ft. dist. (Rec. 65.5 ft.).  
Rotten remains, bears S41°W, 71.5 ft. dist. (Rec. 71.9 ft.).

III. Established two new bearing trees:

A fir, 10 ins. diam., bears N78°E, 8.4 ft. dist., scribed "BT MS 7367A/3".  
A hemlock, 15 ins. diam., bears S32°W, 36.4 ft. dist., scribed "2 MS 7366A BT."  
(Distances measured to faces of B.T.'s).

Painted bearing trees and attached Land Survey Monument and Bearing Tree signs.

Magnetic Declination: 20° East.

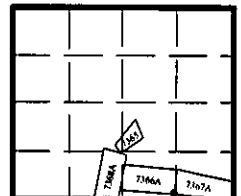
