

INSTRUCTIONS

1. Original and/or subsequent record used to evaluate the corner position.
2. Description of evidence found, note discrepancies in the record, state method of establishing lost or obliterated corners.
3. Description of monument and accessories set to perpetuate the corner position.
4. Sketch of corner, show all pertinent data which can best be shown in a sketch example, corner marking, topography ties, position of accessories, etc.
5. Certification must be signed and sealed by Land Surveyor registered in the State of Montana.
6. Fill in Cross Index & Section Diagram at bottom of sheet.

ORIGINAL AND/OR SUBSEQUENT RECORD

ORIGINAL RECORD: Set a Lime Stone 18" x 12" x 6", 12" in the ground, marked M.C. on E face, with 2 grooves on S face;
 From Which:
 A pine 15" in diam. bears S44°W, 94 lks. dist. mkd. T27N R28W S25 M.C. B.T.
 A pine 24" in diam. bears S36°30'W 90 lks. dist. mkd. T27N R28W S24 M.C. B.T.

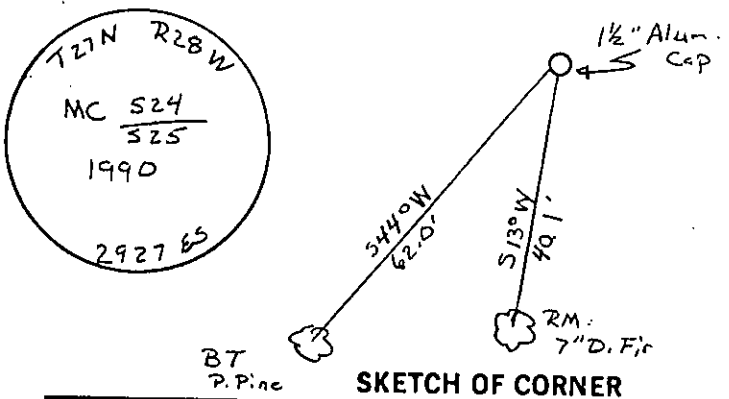
EVIDENCE FOUND

Original Stone Not Found. Found Original BT bears S44°W, 62.0'

PERPETUATION

Set 1 1/2" Alum. Cap from record Bearing and Distance from remaining BT. Mounded monument with stone and set a 5' Steel Fence Post at approximately 1' East of Monument. Established one New RM a 7"D. Fir bears S13°W, 40.1' with MARLS Land Monument Sign. Both RM and BT Trees Painted with Red Band around them.

Note: Declination used - 20°E
 Measurements taken to Center of tree

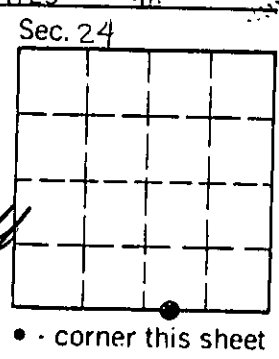
